

BACKGROUND: Summary (continued)

- 1. Anza Valley Christian Men's Service Club \$2,000 will be utilized for the pick-up and distribution of food supplies to the residents of the Anza, and Aguanga areas.
- 2. JDS Creative Academy \$1,000 will be used to provide scholarships for foster and disadvantage youth to attend preforming and visual arts classes.
- 3. EXCEED \$2,500 will support the Work Activity Center in Hemet that provides vocational training for adults with disabilities.
- 4. Kids Court & Counseling Center \$5,000 will be utilized to prepare children to testify and appear in criminal, juvenile, dependency 300, family and civil court.
