## **Summary (continued)**

- 1. Rancho Damacitas \$5,000 the funding will be utilized for the Success, Opportunity, Achievement, Results Program which is an independent living program for foster youth between the ages of (16-21) in care or extended foster care, and/or former foster individuals between the ages so (18-21) aftercare.
- 2. California Family Life Center \$2,000 the funding will be used for guardianship assistance, parenting classes and support groups for families or relatives raising relative children.
- 3. The Debbie Chisholm Memorial Foundation \$2,500 the funding will be utilized for the Debbie Chisholm fundraiser which supports families with seriously ill children at home and provides them a complete Christmas holiday.
- 4. Michelle's Place \$5,000 the funding will be used to provide free low cost breast health services to women and their families.
- 5. Rose Again Foundation \$2,500 the funding will be utilized for foster children to take part in activities such as camp, sports and art associated activities.
- 6. Voices for Children \$5,000 the allocated funding will support Court Appointed Special Advocates, (CASA's) for foster children ages newborn to 21 in Riverside County, and provides a special volunteer advocate for the child's best interest.
