BACKGROUND:

Summary (continued)

Riverside County's University Health System requires a laundry service contract to rent, collect, transport, treat, and clean soiled linen products and medical uniforms used by the department and its patients. The current agreement with Crothall Laundry Services provides laundry rental services, laundering services for customer-owned goods, and the rental of automatic uniform apparel dispensing equipment for Riverside University Health System. This agreement ensures that all linen products and medical uniforms used by the department are cleaned and treated in accordance with the proper cleaning procedures as outlined in the Centers for Disease Control and Prevention; The National Association of Institutional Linen Management; and the California Code of Regulations.

Impact on Citizens and Businesses

There is no negative impact on citizens or businesses in the County of Riverside.

SUPPLEMENTAL:

Additional Fiscal Information

Funds for this contract have been allocated for the FY16/17 budget. Budget adjustments are not necessary. Estimated contract costs are based on reports extracted from the county's financial system.

Contract History and Price Reasonableness

The original contract was bid out on PUARC-1110 with 2 respondents. Crothall Laundry Services was the lowest responsive and responsible bidder, and the agreement was approved by the Board of Supervisors on December 14, 2010. The current agreement with Crothall Laundry Services will need to be extended to allow time for County Purchasing and the hospital to review various procurement options.

Crothall Laundry Services has agreed to extend the current agreement with prices intact.

The Agreement between County of Riverside (COUNTY) and Crothall Laundry Services (CONTRACTOR), entered into as of December 14, 2010, is amended as follows:

1. Section 2 (Period of Performance): Delete the first sentence in its entirety and replace with the following: This Agreement shall be effective upon signature of this Agreement by both parties and continue in effect through June 30, 2017, unless terminated earlier.
2. Section 3 (Compensation): Delete the second sentence in its entirety and replace with the following: Maximum payments by COUNTY to CONTRACTOR shall not exceed \$750,000 annually including all expenses.
3. All other terms and conditions of the Agreement not modified herein shall remain unchanged.
