BACKGROUND:

Summary

By Minute Order dated March 1, 2016 (Agenda Item 3-34), the Board of Supervisors authorized the Clerk of the Board to advertise for the Construction of the Temescal Canyon Road Drainage Improvement Project and the Temescal Canyon Road Turn Pocket Widening Project at Lawson Road and Hostettler Road in the Temescal Canyon Area.

Temescal Canyon Road Drainage Improvement Project

Two reinforced concrete drainage boxes will be placed under the road at Coldwater Creek, just north of Glen Ivy Road. The boxes will accommodate the drainage from minor storms and reduce the frequency of road closure. In addition to the concrete boxes, concrete headwalls and guardrails will be constructed on both sides of the road.

The road will be closed to all traffic for approximately two weeks for this construction.

Temescal Canyon Road Turn Pocket Widening Project at Lawson Road and Hostettler Road

Minor widening at the intersection of Lawson Road and Hostettler Road will provide a left turn pocket northbound on Temescal Canyon Road at each location.

The proposed budget as shown on attachment "A" includes the contract award amount and other associated costs.

The County of Riverside Transportation Department recommends award of the following schedules of work in the Contract amount of \$589,530:

Base Bid Schedule 1:	Temescal Canyon Road Drainage Improvement Project
Base Bid Schedule 2:	Temescal Canyon Road Turn Pocket Widening Project
Alternate Bid Schedule 1:	Temescal Canyon Road Turn Pocket Widening Project – Utility adjustments to grade (Verizon)
Alternate Bid Schedule 2:	Temescal Canyon Road Turn Pocket Widening Project – Utility adjustments to grade (Temescal Valley Water District - TVWD)

The County of Riverside (County) is responsible for funding Bid Schedules 1 and 2. The Reimbursement Agreements between the County and Verizon (Frontier) and TVWD to adjust their facilities within the project to grade have been approved by the Director of Transportation or designee pursuant to the delegation of authority established by the Board in Minute Order dated 2/28/06 (Agenda Item 3-52).

The Contractor is qualified to perform the work as outlined in the bid, has executed the contract, and has provided bonds and insurance documents, which meet the requirements of the Contract.

Impact on Residents and Businesses

The Temescal Canyon Road Drainage Improvement Project will improve traffic safety by reducing debris and the frequency of road closure during rain events.

A publicity campaign is planned well in advance of the full closure of Temescal Canyon Road between Glen Ivy Road and Trilogy Parkway. Advanced publicity will include community meetings, notices to homeowner groups, newspaper ads, and direct contact with local companies with trucking operations.

The Temescal Canyon Road Turn Pocket Widening Projects will improve traffic flow by providing a lane for the traffic turning left to move out of the flow of traffic. The Temescal Canyon Road Turn Pocket Widening Projects work will be phased to keep Temescal Canyon Road open during construction.

The projects will be done separately and each will take approximately one month to complete.

The work is scheduled to begin in Summer 2016.

SUPPLEMENTAL:

Additional Fiscal Information

The contract is recommended to be awarded to Kana Engineering Group, Inc. for the total amount of \$589,530. The project will be funded with DIF - AP6 Major Improvement's fund - Temescal Canyon Area, Redevelopment funds authorized by the Board of Supervisors on September 9, 2014 (Agenda Item 4-3), Developer in-Lieu funds, and Miscellaneous [Ash Fee].

There are no General Funds used in this project.

Contract History and Price Reasonableness

Seven bids were received on March 1, 2016, ranging from \$589,530 to \$707,400 (including Base Bid Schedules 1 and 2, and Alternate Bid Schedules 3 and 4). The basis for the selection of a contractor is the lowest responsive and responsible bid.

The lowest responsive and responsible bid was submitted by Kana Engineering Group, Inc. in the amount of \$589,530 which is \$33,694 (5.4%) below the Engineer's Estimate.
