BACKGROUND:**Summary**

Phase 2 Construction of the Landfill Gas Collection System Expansion for Fiscal Year 2015/2016 at the Lamb Canyon Landfill was satisfactorily completed by Tetra Tech BAS, Inc. at a cost of \$34,377.82, and staff recommends approval of the Notice of Completion.

Impact on Citizens and Businesses

This contract ensures the Department's ability to efficiently collect and monitor the landfill gas generated at the Badlands, Corona, Double Butte, and Lamb Canyon Landfills to maintain compliance with air quality regulations.

SUPPLEMENTAL:**Additional Fiscal Information**

This is an administrative action to file the Notice of Completion for only the Fiscal Year 2015/2016 Phase 2 Construction of the Lamb Canyon Landfill Gas Collection System Expansion. No funds are being requested.

To date, a total of three (3) construction phases have been completed at the Badlands Landfill and three (3) phases at the Lamb Canyon Landfill under this contract. A cost summary by construction phase and location is summarized below. The total amount of the contract expended to date is \$489,474.95. \$744,545.75 is the remaining contract amount.



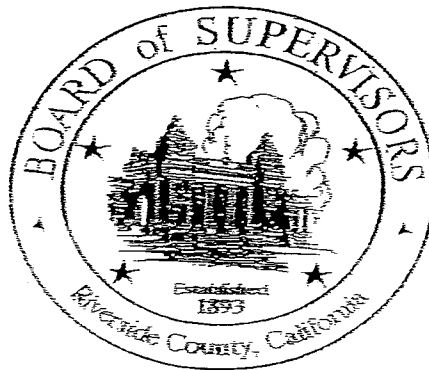
