Born in Los Angeles, California, Sharon was a longtime Legislator who championed a sweeping law that targeted sex offenders and then battled back into political life after her failing health. Her public service began in 1977 when she cofounded Desert Christian Schools which now serves 1,700 students of all ages on three campuses.

Sharon and her husband, George Runner, were the first husband and wife in state history to serve in the Legislature simultaneously. They were instrumental in the drafting and passage of "Jessica's Law" in 2006, a ballot measure that required sex offenders to be monitored with GPS devices and placed rules on how close they could live to schools and parks where children gather.

In 2012, Sharon underwent a double lung transplant and had to drop out of her Senate reelection bid that year. She returned in a 2015 special election after another GOP Legislator was elected to Congress. She previously served six years in the Assembly from 2002 to 2008.

Sharon's memory and passionate spirit will live forever in the hearts of those who knew and loved her.

Bobby, who went by the name DTTX, or Don't Try To Xerox, will always be remembered for breaking barriers in Chicano hip-hop. In 1990, he helped form "A Lighter Shade of Brown" with Robert "One Dope Mexican" Gutierrez. The duo came out of Riverside, California and started recording demos. Later that year, they landed a deal with Pump Records and soon released their debut album "Brown & Proud," which "cracked" the Billboard 200 powered by the classics "Latin Active" and "On a Sunday Afternoon."

A "Lighter Shade of Brown" represented a synthesized sound that reflected the imprint of Chicanos on the culture and helped pave the way for other Chicanos in hip-hop. In 1992, the duo followed up with "Hip-Hop Locos" and also provided songs for movies such as "Mi Vida Loca" and "I Like It Like That." Their third album "Layin' in the Cut" was released by Mercury Records in 1994. After a temprary hiatus, they returned in 1997 on indie with Danny "Dice" and Eric "Bajo" on Thump Records. Their self-titled fourth album featured guest appearances from "Rappin' 4-Tray" and "Dwayne Wiggins."

In 1999, the last of the their releases included a greatest hits album and the single "Sunny Day." That year, Robert became a DJ at San Bernardino Radio Station KGGI and Bobby carried on touring and working on new music. In 2011, the album "It's A Wrap" was reased through Illuminated Entertainment Group. The duo also had a scheduled concert in Las Vegas on August 20, 2016.

Bobby played a pivotal role in the duo's success with his "unique voice" and "energetic, high-pitched, and skilled flow." His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.
