**Summary (continued)**

1. Rotary Club of Murrieta - \$5,000 for the 2016 Murrieta Field of Honor that supports several different activities to honor all Veterans as well as educate children and families about American History.
2. Idyllwild Association of Realtors - \$3,000 the funding will be used for outside equipment for the Idyllwild Town Hall Playground. The funding will be leveraged with another \$3,000 Place Maker Micro grant from the National Association of Realtors.
3. All From the Heart - \$2,500 the funding will be utilized for support of active duty and veteran families in the Southwest area by providing Christmas to needy families.
4. Forest Folk - \$2,000 the funding will support the Idyllwild area shuttle service to underserved senior and disabled individuals in the Idyllwild and Pine Cove areas.
5. Community Outreach Ministry - \$1,000 for the Angel Tree Christmas event which opens doors to connect with children whose parents are incarcerated by providing food and clothing.
