**Summary (continued)**

1. Idyllwild Arts Foundation - \$2,500 the funding will be utilized as a fundraiser for the Idyllwild Jazz in the Pines event. Funding raised from this event will provide scholarships to deserving and talented students in the area.
2. Professional Women's Roundtable - \$1,000 the funding will support the Leadership in Excellence Expo event and scholarships educational assistance for young women.
3. California Inland Empire Council- Boy Scouts of America - \$4,000 the funding will be used for camperships for scouts that need financial support to attend a week long summer camp.
4. Smiles for Seniors - \$1,000 will support the Senior Emergency Assistance Fund which serves seniors to provide food, housing and medical equipment.
