BACKGROUND: Summary (continued)

- 1. City of Hemet \$5,000 the funding is a sponsorship for the Hemet Christmas parade which builds community connection and serves thousands of Hemet and San Jacinto residents.
- 2. Hemet Community Pantry \$3,000 the funding will be utilized for food supplies and to assist seniors with utility assistance.
- 3. Hospice of the Valleys \$2,500 the funding will support Hospice of the Valley's main fundraiser to funds to cover the cost of medication delivery, durable medical equipment and patient visits by nurses and social workers to individuals who are in need of hospice services.
- 4. NAMI \$2,000 the funding will assist with NAMI walk held at Diamond Valley Lake annually. The funds raised at the walk serve persons with mental health diagnosis and their families by providing educational classes throughout Riverside County.
- 5. NAACP Branch 1034 \$1,500 the funding will support the ACT-SO (Academic, Cultural, Technological and Scientific Olympics). The ACT-SO achievement program is designed to recruit, stimulate and encourage high academic and cultural achievement among African-American high school students.
