BACKGROUND:

Summary (continued)

The Board approved a contract with Mamco, Inc. dba Alabbasi Construction and Engineering in the amount of \$26,777,777.00 as Agenda Item 11-6 on March 10, 2015. Upon resolution of all change orders, extra work, and final quantities, the total payment for this contract is \$27,455,077.80 which represents an increase of 2.53% over the Board authorized amount. The District does not anticipate any claims for additional compensation from the contractor.

Per Section II, Article 2.07A, Board authorization of Contract Change Order No. 2 is necessary to ratify payment for Extra Work exceeding \$100,000. The Contract Change Order is associated with the protection of Southern California Edison (SCE) power poles located adjacent to the project and the rehabilitation of 2,200 feet of Menifee Road, as requested by the City of Menifee (City), and amounts to a total of \$289,166.93.

The limited clearance to adjacent SCE transmission poles and overhead transmission lines during construction through SCE's property required the contractor to implement a shoring system in compliance with SCE's Temporary Entry Permit. The shoring system qualifies as an "active protection measure" and shall be compensated by the District as defined in Section 30.3 – SCE Power Pole Protection in the contract's Detailed Specification. The total cost for this Extra Work is \$205,238.73.

Additionally, the City requested the District extend the paving limits beyond the District's trench limits an additional 2,200 feet along Menifee Road between Case Road and Biscayne Road. The City-requested street rehabilitation was incorporated into the District's construction contract with the City agreeing to fully reimburse the District for all costs associated. The total cost for this Extra Work is \$83,928.20 and accounts for the difference between "Total Cost" and "Net District Cost" shown in the Financial Data Cost Table on page 1. The full amount for this Extra Work will be reimbursed by the City to the District. See attached reimbursement confirmation letter from the City and accompanying City Council Minute Order.

Final inspection of the above-referenced project was made, and the project was found to be complete according to the plans and specifications. A brief project description and location map are attached.

Impact to Residents and Businesses

The District constructed a segment of drainage infrastructure described in the District's Romoland Master Drainage Plan as Romoland MDP Line A, Stages 4, 5 and 6, Romoland MDP Lines A-2 and A-3, Stage 1, and Briggs Basin. In conjunction with the District's Homeland MDP Line 1, Stage 1, completion of this drainage infrastructure will reduce the floodplain by approximately 1,762 acres and enable revisions to the FEMA Flood Insurance Rate Maps that result in a significant reduction in flood insurance premiums. The District's Homeland MDP Line 1, Stage 1 project is currently ongoing with an anticipated completion in February 2017.

The District's collaboration with the City to incorporate the City-requested street rehabilitation into the construction contract enabled delivery of a more complete public works project and minimized inconvenience to the public, while providing a cost savings to the City in terms of contract administration, inspection staff, contractor mobilization and general overhead.

Contract History and Price Reasonableness

Pursuant to Public Contract Code 21091, invitation of sealed bids was solicited by advertising in print and digital media.

	This change order will cover two (2) items of Extra Work that the Contractor completed during the course of construction for which no payment item was included in the contract. The Contractor was directed to do the Extra Work described in this change order on a Lump Sum Basis in accordance with Section II, Article 2.07.
	1) Romoland MDP Line A, Stage 5 required construction within Southern California Edison's (SCE) property and adjacent to SCE's transmission poles and overhead transmission lines. The Contractor was directed to implement a beam and plate cantilever shoring system to ensure compliance with SCE's Temporary Entry Permit to construct the project within SCE's property. The additional shoring qualifies as an "active protection measure" as defined in the contract's Detailed Specifications, Section 30.3 – SCE Power Pole Protection. The Extra Work includes an engineered design of the shoring system, installation and removal of the shoring system, and all incidentals related to construction within SCE property. The associated lump sum cost for the Extra Work is \$205,238.73.
	2) The District's Romoland MDP Line A, Stage 5 alignment parallels McLaughlin Road and crosses Menifeed Road. The original contract required the District to pave the full width of the McLaughlin Road – Menifeed Road crossing that was disturbed during the construction of the facility.
	However, the City of Menifee requested the District incorporate additional pavement rehabilitation beyond the contract limits in the construction contract that will be fully reimbursed by the City. The additional paving rehabilitation includes an additional 2,220 lineal feet of full-street width, 2-inch overlay along Menifee Road between Case Road and Biscayne Road, and includes replacing the existing pavement striping in-kind. The lump sum cost for the Extra Work is \$83,928.20 and shall be paid for solely by the City of Menifee.
	Attached for reference are the City of Menifee's statement of reimbursement, City Council approval for reimbursement, and the Contractor's cost breakdown.
	The total lump sum cost associated with this change order is \$289,166.93 and will constitute to compensation, including all direct and indirect costs, associated with the aforementioned work. Per prior communications you have had with my staff, please accept this letter as authorization for RCFCWD to authorize additional work for its contractor to perform additional paving on Menifee Road as part of the ongoing Line A construction work. We have an item on the May 18, 2016 City Council Agenda to obligate funds from our Pavement Management Program to fund this work.


The City will pay the cost for the additional paving on Menifee Road between Mathews Road and Byscane Road and will reimburse RCFCWD. Per the email from Simon Tse, paving of the additional portion of Menifee Road will commence during the road closure period of Menifee Road. The City portion of that work is approximately 54,640 SF of asphalt material and lane striping equaling approximately \$88,345.40. The City understands that field adjustments may be necessary and that can affect the overall quantity and resulting costs; however, I would appreciate notification of any substational cost increases prior to the end of the paving project.

Thank you for continuing to work and coordinating with my staff.

Mayor Mann called the Regular Meeting to order at 7:01 p.m.

2. ROLL CALL

5.1. Fire Battalion Chief Jorge Rodriguez Promotion Recognition

Mayor Mann and the City Council recognized Battalion Chief Jorge Rodriguez for his promotion to Assistant Fire Chief in the desert area. Mayor Mann noted his long extensive career that started as a seasonal firefighter and thanked him for his leadership in Menifee since 2009. Mayor Mann presented Battalion Chief Rodriguez with a plaque.

City Manager Robert Johnson thanked Battalion Chief Rodriguez for being a part of the executive team for the past seven years and said he will be missed.

Battalion Chief Jorge Rodriguez said it was a pleasure working with the Menifee City Council and City staff and he has appreciated the support from the community members.

Councilmember Denver reported that he hosted two families from India via the Rotary Club and enjoyed their company and conversations.

Councilmember Liesemeyer reminded everyone of the Relay for Life event on Saturday, May 21, 2016 being held at Paloma Valley High School.

Councilmember Sobek reported that a Health and Wellness Fair will be held at the Kay Ceniceros Senior Center on Monday, May 23, 2016 from 10:00 a.m. to 2:00 p.m.

Mayor Mann announced that this Memorial Day is the 150th anniversary of the holiday recognizing service men and women who have fallen.

Mayor Mann reported on the Mayor's roundtable with leading healthcare executives in Riverside County. They discussed ways of providing more information to the community about health programs they might not be aware of.

12. DISCUSSION ITEMS

12.1. Participation in the Federal MAP 21 – Surface Transportation Program for the Resurfacing of Newport Road (Bradley Road to Murrieta Road)

Public Works Director Jonathan Smith introduced Senior Engineer Carlos Geronimo to present the item.

Mr. Geronimo reported on the background of the Newport corridor and the current and completed projects. Mr. Geronimo stated that the City has received a grant for federal funding to resurface Newport Road from Murrieta Road to Bradley Road. He said that the timing to complete the

project is very rigid and the City must abide by the required schedule or the City could lose the funding.

The City Council asked questions about the project timing and the material used for the project.

Councilmember Liesemeyer made a motion to approve staff's recommendation of the following:


Councilmember Denver asked to include the reasons it is beneficial for Council to attend the routine regional boards and commissions meetings and conferences.
