



**BACKGROUND:**

1. The donation to Good Hope Missionary Baptist Church will be used to sponsor their "Mountain Movers" Banquet which raises funds for the Reverend Alonzo Simmons Scholarship Fund, which helps under privileged students attend college.
2. The donation to the Corona-Norco Family YMCA will be used sponsor their Youth in Government Program which is for low income high school students from the Corona and Norco area to participate in a six-month, hands-on experience that teaches the values of democracy, how to solve community problems through the democratic process and the students are taught how to advocate and create bills about pertinent issues facing society.
3. The donation to the Riverside African-American Historical Society will be used to support the Eleanor Jean Grier Leadership Academy, which is a 12 week leadership course whose mission is to teach leadership skills and increase civic and community participation among the underrepresented groups in the County of Riverside.
4. The donation to the Fit One Foundation will be used to provide a mobile unit to take their free classes to the communities of Home Gardens and Jurupa, as well as to continue to provide the free classes for kids at their facility in Riverside.
