BACKGROUND:

Summary

County Counsel provides legal services to the Board of Supervisors and its numerous agencies and departments. The office has and continues to provide legal services to Riverside University Health System (RUHS) including general advice, contract services and compliance issues. In order to provide additional contract services due to ever increasing demands, County Counsel and RUHS have determined there is a need for one full time Paralegal II-CN position to assist RUHS and the assigned Deputy County Counsel with contract negotiations, implementation and oversight. The addition of this paralegal position will provide these additional services at a lower cost to RUHS than can be provided through existing staff. As a result, RUHS has agreed to fund one full-time paralegal position dedicated to providing additional contract services for RUHS.





BACKGROUND:

The Office of County Counsel therefore requests to add one (1) position of Paralegal II-CN to accommodate the increased level of service. This position will be funded by RUHS. There will be no additional impact on the general fund as increased revenues will offset additional expenses. A budget adjustment will be included in the FY 16/17 1st Quarter Report to increase appropriations to salary expense and for the offsetting revenue.
