**BACKGROUND:**

**Summary**

The County Transportation Improvement Program (TIP) provides for the Columbia Street Resurfacing Project in the East Hemet area. The project limits are Florida Avenue to Stetson Avenue, approximately 1.2 miles.

The project will remove and replace the existing asphalt pavement. Additionally, the existing concrete curbs, gutters and sidewalk that are in poor condition will be reconstructed, and Americans with Disabilities Act (ADA) compliant access ramps will be constructed or reconstructed to comply with new ADA standards.

Additional work includes removal and replacement of asphalt concrete berms, shoulder grading, manholes adjustments, new striping, pavement markings and other work as required.

A portion of Columbia Avenue is in the City of Hemet, it includes the westerly half of the street, from Florida Avenue to 953 feet southerly of Florida Avenue. The City of Hemet has been invited to participate in the project and work within the City of Hemet is specified in Alternate Bid Schedule 1. If the low bid is approved and concurred to by the City of Hemet, a Reimbursement Agreement between the City of Hemet and the County of Riverside (County) will be approved by the City of Hemet and the Board of Supervisors prior to or concurrent with the award of the construction contract.

The purpose of this project is to resurface the road to provide the public with a smooth driving roadway that will improve the safety for vehicular traffic and extend the life of the road.

The bid documents include the following bid schedules of work:

Base Bid:	Resurfacing and associated road improvements
Alternate Bid Schedule 1:	City of Hemet – Resurface portion of Columbia Street in the City of Hemet

The submitted plans and specifications have been approved as to form by County Counsel.

**Environmental findings**

CEQA Guidelines Section 15301(c) describes the minor alteration of existing public facilities with negligible or no expansion of an existing use as a categorical exemption under CEQA; the project qualifies under this exemption since it is a maintenance activity with minor alteration of an existing road and associated facilities.

In addition, the Columbia Street Resurfacing is covered by the general rule of the CEQA Guidelines Section 15061(b)(3). The Columbia Street Resurfacing Project involves minor improvements and alterations to an existing roadway. As a result, there is no possibility that the resurfacing project will have a significant effect on the environment. Therefore, the resurfacing project is exempt from CEQA because it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

The County will serve as the CEQA lead agency on behalf of the City of Hemet.

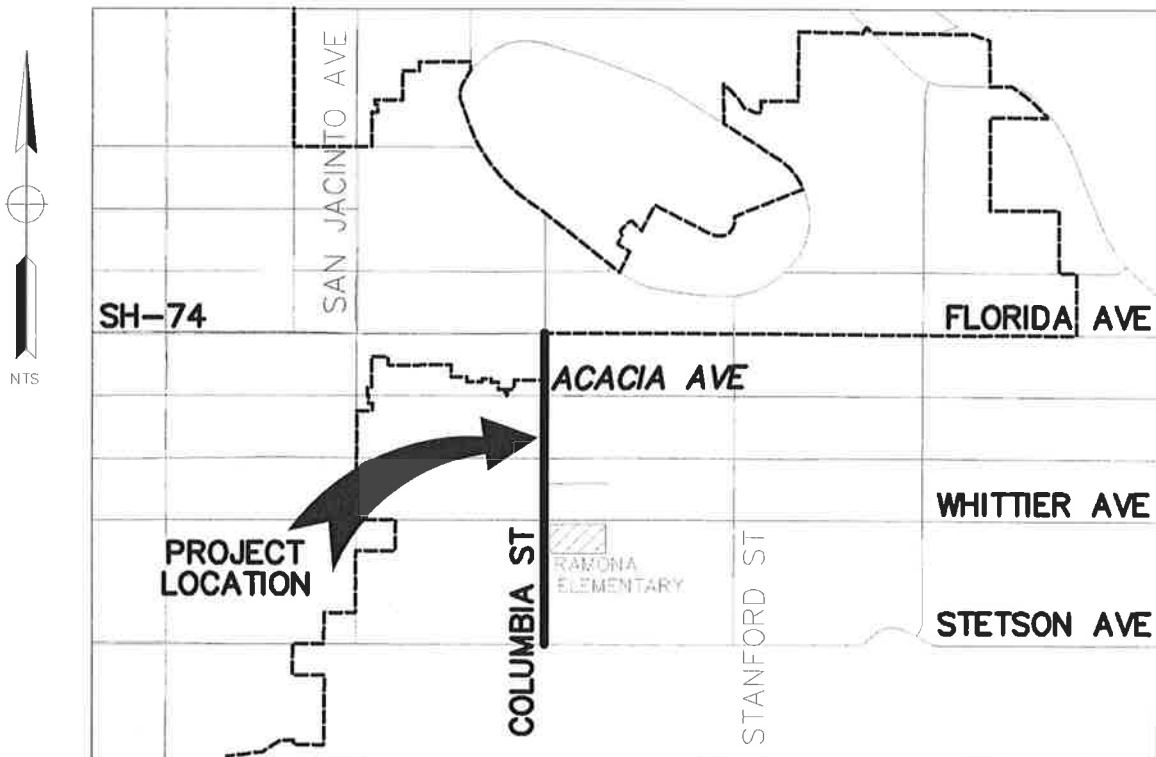
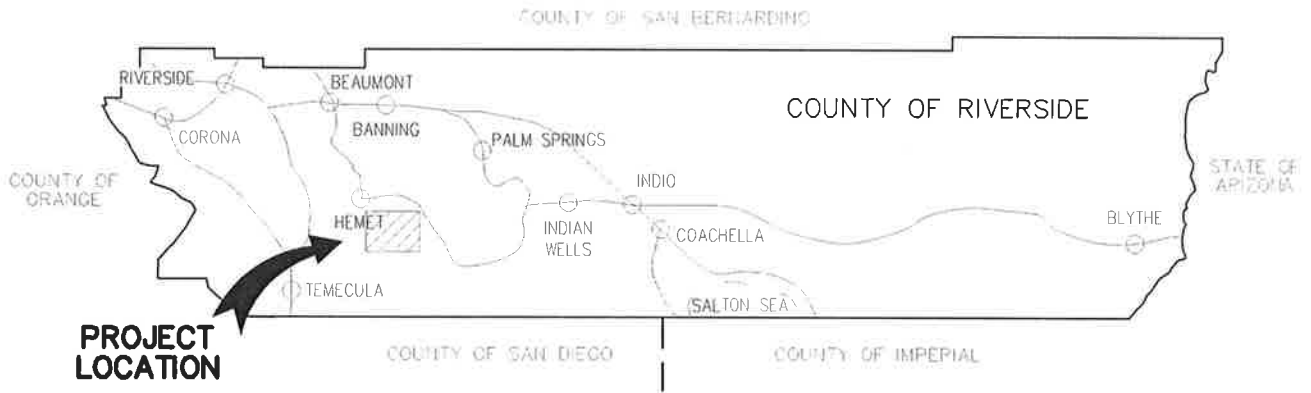

**PROJECT LOCATION:** Located in Western Riverside County, East Hemet Community

**SUPERVISORIAL DISTRICT:** Third

**PROJECT DESCRIPTION:** The Riverside County Transportation Department (RCTD) proposes to resurface Columbia Street from Florida Avenue to Stetson Avenue for a total distance of approximately 1.2 miles in the East Hemet area. The project will include the following:

- Removal of the existing asphalt pavement and place 0.13' of Rubberized Hot Mix Asphalt over 0.20' of Hot Mix Asphalt.
- Reconstruct damaged portions of existing concrete curbs, gutters and sidewalk.
- Construct four new ADA compliant access ramps and reconstruct six existing access ramps to comply with the ADA standards.
- Reconstruct eight existing concrete cross-gutters. Two of the cross-gutters, at Mayberry Ave and north of Tava Lane will be replaced with wider, shallower, cross-gutters to reduce damage from low vehicles.

Additional work includes removing and replacing asphalt concrete berms, grading shoulders, adjusting manholes to grade, adjusting water valve covers, new striping, pavement markings and raised pavement markers and other associated work as required.

A portion of Columbia Street is within the City of Hemet. However, the Riverside County Transportation Department will serve as the CEQA lead agency. The City portion includes the westerly half of the street from Florida Avenue to 953 feet southerly of Florida Avenue.

In accordance with Section 7.1 of the Western Riverside County MSHCP, necessary operation and maintenance along existing roadways are considered a covered activity outside cell criteria areas. The project will comply with MSHCP construction guidelines and BMP's. A pre-construction nesting bird survey will be required if construction takes place during the nesting bird season.

The Riverside County Transportation Department Staff conducted a review of the above referenced project and has determined that the proposal qualifies for a Categorical Exemption per the California Environmental Quality Act (CEQA) Guidelines.

**The Riverside County Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA), based on the following:**

**California Environmental Quality Act Guidelines:**

**Section 15301 (c) – Existing Facilities** – The project proposes to resurface Columbia Street and reconstruct the existing concrete curbs, gutters and sidewalk. This minor alteration to the existing public structure involves negligible or no expansion of use and is exempt from CEQA under Section 15301 (c). The improvements are consistent with Section 15301(c) because the project is repair and maintenance of an existing road and associated facilities.

**Section 15061(b)(3) – General Rule Exemption** – The project is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. The project involves maintenance and improvement of an existing street within the existing paved street, and therefore it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.
