BACKGROUND:

Summary

1. The Coachella Valley Association of Governments' Homelessness Committee will be authorizing the purchase of bus passes from the Sunline Transit Agency for the benefit of local homelessness service providers. Clients will be able to utilize the SunLine Bus to access supportive services and seek employment so that they can become self-sufficient. The CID funds will be used to purchase bus passes.
2. Riverside University Health System Foundation's Festival of Trees is an annual fundraiser for the purchase of desperately needed and often lifesaving equipment for the children's units at the Riverside University Health System Medical Center. CID funding will be used toward the cost of equipment and support programs that benefit the children's units at RUHS.
