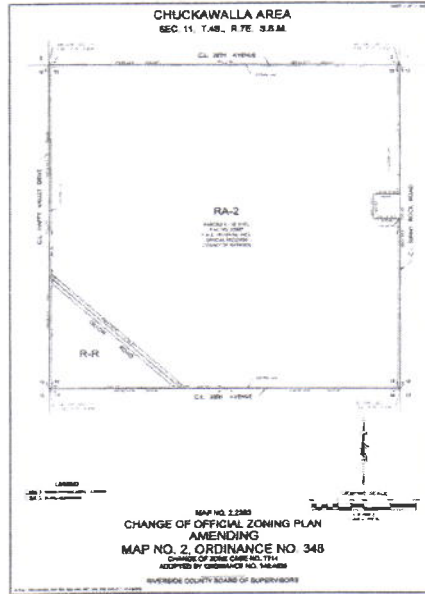

ORDINANCE NO. 348.4830
AN ORDINANCE OF THE COUNTY OF RIVERSIDE
AMENDING ORDINANCE NO. 348 RELATING TO ZON-
ING

The Board of Supervisors of the County of Riverside or-
dains as follows:

Section 1. Section 4.1 of Ordinance No. 348, and offi-
cial Zoning Plan Map No. 2, as amended, are further
amended by placing in effect in the Chuckwalla Area, the
zone or zones as shown on the map entitled "Change of
Official Zoning Plan Amending Ordinance No. 348, Map
No. 2.2393, Change of Zone Case No. 7714" which map
is made a part of this ordinance.

Section 2. This ordinance shall take effect 30 days af-
ter its adoption.
