
SUBJECT: Second District Use of Community Improvement Designation (CID) Funds

BACKGROUND:

1. The donation to Big Brothers Big Sisters of the Inland Empire will be used to support the "Road to Success" Initiative which matches qualified high school students as mentors to elementary school students which helps break the cycle of poverty, low academic attainment and juvenile delinquency.
2. The donation to the Food Runners Club will be used to help sponsor their Fall Harvest Festival which raises money for the organization to assist with food handling permits, facility permits, cooking classes and other activities for teens in the program, such as their annual college exploration trip.
3. The donation to the Rubidoux High School Choir will be used to help purchase new choir uniforms (dresses, tuxedos and shoes) for students to wear during performances throughout the year.
4. The donation to the Uptown Kiwanis will be used to sponsor their annual fundraiser wherein funds are raised to support various community programs such as adopting needy families at the holidays, Operation School Bell and other worthy causes.
