**BACKGROUND**

**Summary**

Recently, the U.S. Securities and Exchange Commission amended the rules that govern the operation of Money Market Funds. The objective is to offer greater protection and transparency for fund shareholders and allow the ability to promote stability in the financial markets. However, those amendments will impose additional restrictions and fees on a plan participant's ability to withdraw or transfer monies out of certain types of money market funds during times of market stress. Under the new rules, money market funds will be required to classify themselves as either retail, institutional, government, or tax-exempt.

The money market funds currently being offered in the County of Riverside Deferred Compensation retirement plans will become subject to the new restrictions and fees, which affects the plan participant's ability to access any assets invested in those funds. In order to avoid imposing fees and/or restrictions to the money market funds currently offered by the County, a change to the current money market fund to a government money market fund is necessary. Government money market funds are not subject to the new restrictions and fees. In order to avoid imposing fees and/or restrictions to the money market funds currently offered by the County, fund changes will need to be made to the money market funds line-up by October 2016 to a government money market fund.

The existing money market fund, the Vanguard Prime Money Market Investment Fund (VMMXX), will be replaced with the Vanguard Federal Money Market Fund (VMFXX). This change will impact existing assets and future contributions that occur on or before October 14, 2016.

There is no direct impact on residents or businesses in the County of Riverside.

**BACKGROUND**

**Summary**

Recently, the U.S. Securities and Exchange Commission amended the rules that govern the operation of Money Market Funds. The objective is to offer greater protection and transparency for fund shareholders and allow the ability to promote stability in the financial markets. However, those amendments will impose additional restrictions and fees on a plan participant's ability to withdraw or transfer monies out of certain types of money market funds during times of market stress. Under the new rules, money market funds will be required to classify themselves as either retail, institutional, government, or tax-exempt.

The money market funds currently being offered in the County of Riverside Deferred Compensation retirement plans will become subject to the new restrictions and fees, which affects the plan participant's ability to access any assets invested in those funds. In order to avoid imposing fees and/or restrictions to the money market funds currently offered by the County, a change to the current money market fund to a government money market fund is necessary. Government money market funds are not subject to the new restrictions and fees. In order to avoid imposing fees and/or restrictions to the money market funds currently offered by the County, fund changes will need to be made to the money market funds line-up by October 2016 to a government money market fund.

The existing money market fund, the Vanguard Prime Money Market Investment Fund (VMMXX), will be replaced with the Vanguard Federal Money Market Fund (VMFXX). This change will impact existing assets and future contributions that occur on or before October 14, 2016.
