

AGREEMENT TO PURCHASE TAX-DEFAULTED PROPERTY

This Agreement <u>4428</u> is made this <u>37th</u> day of <u>5000</u> 2010, by and between the Board of Supervisors of Riverside County, State of California, and the <u>Idyllwild Water District</u> ("PURCHASER"), pursuant to the provisions of Division 1, Part 6, Chapter 8, of the Revenue and Taxation Code.

On August 28, 2015, the Idyllwild Water District applied to purchase the subject properties (Exhibit "A").

The real property situated within said County, hereinafter set forth and described in Exhibit "B" attached hereto and made a part hereof, is tax-defaulted and is subject to the Power of Sale by the Tax Collector (Exhibit "C") of said County for the nonpayment of taxes, pursuant to provisions of law.

A certified copy of the Resolution authorizing the purchase of the property by the **Idyllwild Water District** is attached as Exhibit "D".

It is mutually agreed as follows:

- 1. That as provided by section 3800 of the Revenue and Taxation Code, the cost of giving notice of this Agreement shall be paid by the PURCHASER, and;
- 2. That the PURCHASER agrees to pay the sum of \$2,350.00 for the real property described in Exhibit "B" within fourteen (14) days after the date this Agreement becomes effective. Upon payment of said sum to the Tax Collector, the Tax Collector shall execute and deliver a deed conveying title of said property to PURCHASER;
- 3. That the PURCHASER agrees to use the parcel(s) for public purpose under the following intent: **To construct monitoring Wells for District benefit**;
- 4. That, if said Purchaser is a taxing agency as defined in the Revenue and Taxation Code, section 121 or any other agency that receives its revenue share under the provisions of Division 1, Part 8, Chapter 3 of the Revenue and Taxation Code, it will not share in the distribution of the payment required by the Agreement as defined by section 3791 and section 3720 of the Revenue and Taxation Code.
- If the intended schedule and effective date of the Agreement is delayed, the Purchaser and the Board of Supervisors will renegotiate the increase of the purchase price amount accordingly.

If all or any portion of any individual parcel described in this Agreement is redeemed prior to the effective date of this Agreement, this Agreement shall be null and void as to that individual parcel. This Agreement shall also become null and void and the right of redemption restored upon the PURCHASER'S failure to comply with the terms and condition of this Agreement.


**BACKGROUND:** Recently, the District was informed that two small properties were available for acquisition due to tax delinquencies. The District was informed of the property availability because the properties are located under joint ownership with the Pine Cove Water District. Tax delinquent properties are first offered to public agencies, prior to being available for public auction. The value of the property is set by negotiations, taking into account the cost of County paperwork, transfer fees, the past due taxes and the fair market value of the site. The final purchase price was determined in keeping with Section 3698.5 (a) of the Revenue and Taxation Code, of the State of California. The two properties are identified as APN 560110008-1, and APN 560110013-5.

ANALYSIS: The properties are proximate to the Dutch Flat area and are ideally suited for monitoring wells. This would be a valuable asset to the District as it moves into its recycled water project. Staff was able to negotiate a fair price for the two properties at a value of \$1,175.00 each.




