SUBJECT: Acceptance of grant funding from the South Coast Air Quality Management District's Plug-In Electric Vehicle (PEV) Infrastructure Rebate Program; [1st & 2nd Districts; \$22,500 grant funds]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve the acceptance of the Grant Award from the South Coast Air Quality Management District's (SCAQMD) Plug-In Electric Vehicle (PEV) Infrastructure Rebate Program in the amount of \$22,500; and,
2. Authorize the Director of Purchasing and Fleet Services to administer all actions necessary and sign all documents related to the acceptance of this grant award on behalf of the County of Riverside.

Policy

BACKGROUND:

Summary

The Purchasing and Fleet Services Department has been awarded a grant by SCAQMD for the installation of electric vehicle charging stations at two Purchasing and Fleet Services facilities on 2980 Washington Street, Riverside and 5293 Mission Blvd., Rubidoux. The funding is provided through SCAQMD's PEV Infrastructure Rebate Program, as a way to assist local government fleets with the cost in transitioning to zero emission PEVs. Fleet Services applied for and received a grant award in the amount of \$22,500 to cover the purchase and installation of ChargePoint EV Charging Stations.

BACKGROUND:

Summary (continued)

Purchasing and Fleet Services purchased four Nissan Leaf PEVs in FY15-16, to replace gas engine vehicles in our motor pool fleet. The department estimates that by deploying PEVs, the County will save 1,000 gallons of unleaded gasoline per vehicle per year. The ability to employ 2 EV charging stations at County Fleet Services facilities will ensure a quick turn-around of rentals as a result of the swift recharging capability.

Impact on Residents and Businesses

Fleet Services shares the Board of Supervisor's commitment making Riverside County a safer place to live and work, and routinely searches out grant funding to accelerate the Fleet's transition to low/zero emission vehicles. By accepting this grant, Fleet Services is following Board Policy D-2 by expanding the infrastructure needed to sustain a zero emission fleet. Accepting the grant will also assist Fleet Services in conforming to AB32, the Clean Air Act and SCAQMD's clean air standards as required by 2023.
