BACKGROUND:

Summary (continued)

The Riverside County Probation Department (Probation) applied for and received a \$300,000 grant award from the U.S. Department of Justice, Office of Justice Programs through the Adult Drug Court Discretionary Grant Program. The grant will be used to support the Riverside County Veterans Court-Military Diversion Enhancement Program operated in partnership with the District Attorney, Public Defender, and the State of California Superior Court, County of Riverside. The grant performance period is October 1, 2016 thru September 30, 2019.

The Veterans Court (VC) program was started on January 5, 2012 to provide treatment services to reduce crime and substance abuse among high-risk/high-need veteran offenders. According to the Loma Linda Veteran's Administration, as of 2010, the veteran population in Riverside County was 127,000 in a fast growing county of 2,100,516 people. As soldiers return home from military duty, the county anticipates that many will choose to live in Riverside due to lower housing costs and the close proximity to veteran services. The demographics of the veteran population seeking treatment in Riverside are: Gender: Male 96.5%, Female 3.5%; Race: White 45%, African American 9%, Latino 42%, Other 4%; and Age: 18-25 7%; 26-30 25%; 31-40 25%; 41-50 27%, over 50 27%. Additionally, a large percentage of the veteran population also needs mental health services for post-traumatic stress disorder, psychological issues, and/or traumatic brain injury. Of the veterans referred to the VC program, 33% of those assessed in a six month period required treatment for some or all of the above mental health disorders.

Several nonviolent offenses were converted to misdemeanors when California Proposition 47 was approved on November 4, 2014. Many veterans that would have been considered for VC due to a felony arrest are now being charged as misdemeanors. Probation and its justice partners recognized a need to modify the existing VC program to accommodate this change in the law in order to continue providing a coordinated response to veterans with mental health and substance abuse needs. The VC expects to service 90 new clients within the three-year grant period, including the existing 43 clients, for a total of 133 high-risk/high-need misdemeanants and felons over the lifetime of the grant.

Impact on Residents and Businesses

Substance abuse use is a countywide challenge that requires a countywide response. Veteran offenders suffering from substance abuse in conjunction with mental health concerns is an area that county agencies have been working collaboratively to address. The receipt of these funds will assist with providing needed rehabilitation to reduce crime and substance abuse among high-risk/high-need veteran offenders; will help to improve success rates; and will result in less crime and increased community safety.

The grantor requires a county cash or in-kind match of at least 25% of the program cost. The total program cost is \$406,926, and the grant funds 74%, or \$300,000, of the total program cost. The remaining 26%, or \$106,926, of the total program cost is met through an in-kind match in the personnel and operating categories. Probation's FY16/17 contribution of \$26,731 is already included in the department's budget and funded by the Community Corrections Performance Incentive Act (CCPIA) program. A budget adjustment of \$75,000 is necessary to increase estimated revenues for the current fiscal year cost (see attached Schedule A).

32.
