Officer Zerebny was a loving and devoted wife, mother, daughter, and friend whose memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be dearly missed but never forgotten.



Born in Texas, Officer Vega was a child when he moved with his migrant farmworker parents and siblings to California. He grew up in poverty at the Fred Young Farm Labor Camp in Indio.

A husband and father of eight, Officer Vega had planned to retire in December after a 35-year career with the department. He wasn't scheduled to work the day he died but had volunteered to fill the shift.

Officer Vega received several community awards during his decades-long service and will always be remembered as a true hero and "kind officer who thought of others before himself, especially in emergency situations." In 2012, the Palm Springs Chamber of Commerce honored Officer Vega and Officer John Meja for saving a two-month old girl with CPR. A year later, the Palm Desert Area Chamber of Commerce named him Patrol Operations Officer of the Year.

Officer Vega was a loving and devoted family man and friend whose memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.

Bollenbach, a 74-year-old prominent executive in the hotel industry who passed away on October 8, 2016 in Manhattan.

Born on July 14, 1942 in Los Angeles, California, Stephen lived primarily in East Hampton, New York and also had homes in New York and Paris. He graduated from the University of California, Los Angeles and received a Master's Degree in Business Administration from California State University, Northridge.

Stephen was Chief Executive of the Hilton Hotels Corporation from 1996 until 2007, when he retired. He presided over the acquisition of the Bally Entertainment Corporation, giving the company a presence in Atlantic City, as well as the reunification of Hilton's American and international properties and the expansion of its franchise business. He was the first person outside of the Hilton family to hold that position.

Prior to taking the helm at Hilton, Stephen oversaw the finances of several other companies, including the Trump Organization. When he became their first Chief Financial Officer in 1990, Stephen changed how Mr. Trump financed his empire of buildings, Atlantic City casinos, hotels, and an airline. His financial skills were credited with sparing Donald J. Trump from having to file for personal bankruptcy.

After leaving the Trump Organization in 1992, Stephen returned to the Marriott Corporation and became its Chief Financial Officer. He was also the Chief Financial Officer of Walt Disney. In 1995, he persuaded its executives that the company could afford to take on the debt necessary to acquire Capital Cities/ABC. It was one of the biggest media deals at the time.

Stephen was a loving and devoted family man whose memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.
