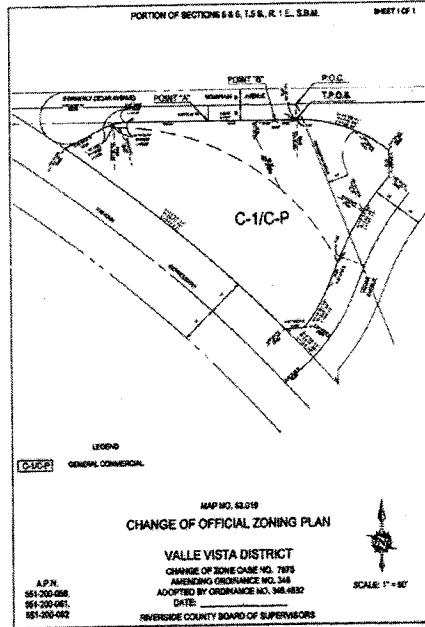

AND ORDINANCE OF THE COUNTY OF RIVERSIDE
AMENDING ORDINANCE NO. 348 RELATING TO
ZONING

The Board of Supervisors of the County of Riverside or-
dains as follows:

Section 1. Section 4.1 of Ordinance No. 348, and Val-
ley Vista District Zoning Plan Map No. 63, as amended,
are further amended by placing in effect in the zone or
zones as shown on the map entitled "Change of Official
Plan, Valley Vista District, Map No. 63.019 Change of
Zone Case No. 7875," which map is made a part of this
ordinance.

Section 2. This ordinance shall take effect 30 days af-
ter its adoption.
