BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. Smiles for Seniors Foundation- \$1,000** to support their efforts of providing emergency assistance for food, housing and utility payments as well as home and auto repair, and help pay for life saving prescriptions, and medical equipment for senior citizens in the 1st District.
- 2. Assistance League of Temecula Valley - \$2,500** funding will be used to support the Operation School Bell program. The program projects to clothe approximately 550 disadvantaged schoolchildren in the First District.
- 3. Big Brothers Big Sisters of the Inland Empire - \$1500** funding will be used to provide support to a free after school program that matches high school students with elementary school students on school campuses in the 1st District to promote academic and social support.
