An instrumental force in the community, Mel was a "great ambassador" of the City of Palm Springs and one of the Coachella Valley's most "iconic figures" as the longtime owner of the Ingleside Inn and Melvyn's Restaurant in Palm Springs. He was also a "gracious host and generous philanthropist" who will always be remembered for his "wit and talent for storytelling."

Born on October 24, 1936 in Brooklyn, Mel moved to Southern California after a visit to Palm Springs in 1974. During this visit he was taken to a property which became the "legendary" Ingleside Inn. In October 1975, on opening night, Melvyn's and the Ingleside Inn welcomed the who's who of Palm Springs and it became an overnight success.

In 1979, Mel parlayed that success into one of the most beautiful and famous discotheques of its time, Cecil's. He continued his string of successful ventures in the 1980's with Doubles, a restaurant at the Tennis Club, as well as Saturdays, a cozy hamburger joint which also served as an after-hours dancing club. After selling Cecil's in 1984, the community continued to clamor for Mel's return to the dance scene. In 1994, he opened Touche, a world-class dance and dining club in Rancho Mirage.

Well-known for his charitable work, Mel served for a quarter of a century as president of the Angel View Foundation, an organization that helps children and adults with disabilities. More recently, he joined the Board of Directors of SafeHouse of the Desert, an organization dedicated to the well-being of homeless, abandoned, and abused children.
