After stepping down from the Attorney General's Office in 2001, Ms. Reno returned to Miami, Florida and ran for Governor. However, depsite her universal name recognition, party officials backed another candidate.

Ms. Reno valued her time in the Attorney General's Office and often said that hers had been an "exciting, interesting, lucky life." She also enjoyed reading, gardening, and kayaking.

"Don" Arends, an 87-year-old prominent resident of Oak Brook, Illinois and La Quinta, California who passed away on October 29, 2016.

Born and raised in Des Moines, Iowa, Don proudly served as a Seabee in the U.S. Navy from 1946 to 1948 and attended Iowa State University in Ames from 1948 to 1952. His education at the now-called Greenlee School of Journalism and Communications started his life-long love affair with writing and creativity which he used to serve others. In 1990, Greenlee School honored him with the James W. Schwartz Award for his distinguished service to journalism and communications.

An instrumental force in the community, Don's service included stints as President of the Iowa State University Foundation; General Chairman of the 1981 USGA Women's Open Championships, held at the La Grange Country Club (LGCC); President of La Grange Country Club; Board of Directors, La Grange Memorial Hospital; and Board Member, La Quinta Historical Society. He was also a certified private pilot and a longtime volunteer, docent, and promoter of the Palm Springs Air Museum. He was recently inducted into the museum's Hall of Honor for his service in creating public interest in the museum, its mission, and its one-of-a-kind experience.

Later in life, Don wrote and published several books through Mission Manuscripts, a company he founded to help preserve and tell the stories of World War II Veterans. He authored several children's books. His bestseller, "Grandpa Grouper, The Fish With Glasses" is read widely in pre-schools throughout Chicagoland and the Coachella Valley, along with his chapbook series, "The Adventures of Norm, the Ninja River Mouse."
