Born on October 13, 1927 in El Segundo, California, John proudly served in the U.S. Navy during World War II aboard the Tulagi Bay. After an honorable discharge, he traveled by boat to New Zealand, where he served a three-year mission for the Church of Jesus Christ of Latter-Day Saints. He returned to America and attended Brigham Young University, during which time he married Geraldine Rohner. Together they went off to USC for dental school.

In 1958, John brought his family to Palm Springs and started a dental practice, where he worked until he was 78 years old. He was well-known and respected within the dental community for his skill as a technician and for his service to organized dentistry. He was one of the founding directors of The Dentist Company and served as the chairman of The Dentist Insurance Company.

An instrumental force in the community, John worked with many charities in the area to benefit others. He was a leader in the LDS Church and was very involved with the Desert Healthcare Foundation, helping raise money to restore the El Mirador Tower. His specialty was in running golf tournmanets to raise funds for various charities and organizations.

For the last 40 years, John was also a pistachio farmer and pioneer in the California pistachio industry. He played a major role in the development of the American Pistachio Growers Association and the Pistachio PAC. He was an "avid golfer" and member of the O'Donnell Golf Club, Canyon Country Club, El Dorado Country Club, Quail Lake CC, The Vintage Club, Bermuda Dunes, and The Quarry.

John was a loving husband to his wife Geraldine who preceded him in death and a devoted father, grandfather, great-grandfather, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.

On motion of Supervisor Benoit, seconded by Supervisor Tavaglione, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, November 15, 2016, be adjourned in memory of Brigadier General Stan Brown, an 87-year-old leader in the Riverside military and business communities who passed away on November 10, 2016.

Born in 1928 in Champaign, Illinois, General Brown enlisted in the USAF in 1950, rose to the rank of Staff Sergeant, then received a direct commission as a 2nd Lieutenant in 1953. His prominent career in the Air Force included numerous overseas tours of duty as well as tours at AF Headquarters in Washington, D.C. Locally, he served as Base Commander at March Air Force Base and was later appointed Wing Commander. He retired from the Air Force in 1983.

General Brown's military decorations and awards include the Distinguished Service Medal, the Legion of Merit with oak leaf cluster, the Bronze Star, the Air Medal with six oak leaf clusters, the Air Force Commendation Medal with two oak leaf clusters, the Vietnam Service Medal with four service stars, and the Republic of Vietnam Campaign medal.

While at March Air Force Base, General Brown lobbied for the establishment of a VA National Cemetery and is credited with bringing the National Cemetery to Riverside in 1978. His service on the VA's National Cemetery Advisory Committee and the Riverside National Cemetery's Memorials and Monuments Committee was instrumental in turning the Riverside National Cemetery into a nationally recognized national shrine.

General Brown also served on the City of Riverside's Planning Commission, the Washington-Alessandro Transportation Advisory Committee, the Citizen Advisory Committee, and the Ad Hoc Mayor's Military Tradition Committee, resulting in numerous City awards and recognitions including the Spirit Award, the Riverside City Salutes Award, the Riverside Chamber's Presidential Award, and the Riverside National Cemetery Dignity Award. For his service to the nation and to his community, the Salute to Veterans Parade Committee honored him as its 2012 Grand Marshal.

General Brown's memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.

Well-respected in his field, Spence received the Barry Thoma Award, the highest award given by the Washington Association of Health Underwriters. Throughout his career, he was active in legislative and regulatory issues, served as chairman of numerous healthcare boards, and was past President of the WA State Health Underwriters Association.

Once retired, Spence and his wife Fran moved to Palm Springs, where he quickly made new friends, enjoyed golfing, and involved himself in the arts. He was on the Advisory Board of Old Town Artisan Studio and actively contributed to Music For Life. He also remained very involved in the Seattle Senior Rights Organization and the Alumni Association of his alma mater, Ballard High School.





The Board of Supervisors commemorates her service to the County of Riverside.


