



BACKGROUND/APPOINTEE INFORMATION:

The Idyllwild Water District is governed by a board of five directors, each of whom, whether elected or appointed, shall be a voter of the district. The term of office of each director shall be four years. All vacancies occurring in the office of director shall be filled pursuant to Section 1780 of the Government Code.

On September 12, 2016, Mr. James Billman resigned as director of the Idyllwild Water District. Four days later, on September 16, 2016, Mr. Michael Patrick Freitas resigned as director.

Pursuant to Government Code section 1780, the Idyllwild Water District had sixty (60) days to call a special election or appoint individuals to fill the vacancies created by the resignation of Mr. Billman and Mr. Freitas. Specifically, the Idyllwild Water District had until November 11, 2016 to make an appointment or call a special election to fill the vacancy created by Mr. Billman's resignation. Additionally, the Idyllwild Water District had until November 15, 2016 to make an appointment or call a special election to fill the vacancy created by Mr. Freitas' resignation.

The Idyllwild Water District failed to call for a special election or fill the vacancies by appointment as allowed to do so under Government Code section 1780. As such, the opportunity to fill the vacancies by special election or appointment is now vested with the County's Board of Supervisors.

Therefore, under the authority vested in the Board of Supervisors, by the State of California, I am making these appointments to fill the vacancies on the Idyllwild Water District.
