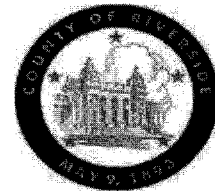



BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the November 8, 2016 Consolidated General Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On September 27, 2016, the Board of Supervisors approved the conduct of election services for the Consolidated General Election. This election includes both federal and state office's elections and elections for certain local jurisdictions. The Registrar of Voters will receive reimbursement from local jurisdictions that have added a measure or special election to the November ballot for the full cost of conducting their election. Election costs fully reimbursable from local jurisdictions are approximately \$3,500,000. Elections for federal and state offices are not reimbursable and are funded by the department's budget.

The election was held on November 8, 2016 with about 75% voter turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast at the Consolidated General Election.

Impact on Residents and Businesses

Registered voters who reside in the County of Riverside had the opportunity to elect candidates for federal and state offices and local jurisdiction offices.

Additional Fiscal Information

As approved by the Board of Supervisors on September 27, 2016, local jurisdictions that have added a measure or special election to the November ballot will reimburse the Registrar of Voters for the full cost of conducting their election.
