On motion of Supervisor Tavaglione, seconded by Supervisor Washington, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, January 17, 2017, be adjourned in memory of Riverside County Supervisor John J. Benoit, a 65-year-old resident of Bermuda Dunes, California who passed away peacefully at his home on December 26, 2016.

Supervisor Benoit served as Riverside County Fourth District Supervisor from 2009 to 2016 and was Chairman of the Riverside County Board of Supervisors in 2013 and 2016. He was appointed to the Board of Supervisors in 2009 and was elected to a second four-year term in 2014. The Fourth District covers the eastern two-thirds of the County, stretching from Palm Springs and Desert Hot Springs, south to the Salton Sea, and east to Blythe and the Colorado River.

After graduating from Notre Dame High School in Riverside, Supervisor Benoit began his prominent career with the Corona Police Department. His thirty-one years in law enforcement included twenty-nine years with the California Highway Patrol, working in Los Angeles, Sacramento, and Bakersfield. In 1988, he made the Coachella Valley his home when he was promoted to Commander of the California Highway Patrol's Indio Station.

While working for the CHP and raising a family, Supervisor Benoit earned an Associate's Degree from Riverside City College, a Bachelor of Science Degree in Public Safety from Cal State Los Angeles, and a Master's Degree in Public Administration from Cal State San Bernardino. He attended the FBI National Academy and served as a Volunteer Fire Captain with the Sunset-Whitney Fire Department. He also took Spanish-language immersion programs in Mexico and Costa Rica to better serve Spanish-speaking residents.

Supervisor Benoit's first elected office was as a Board Member of the Desert Sands Unified School Board. He was elected to three terms in the California State Assembly from 2002 to 2008 and served in the California State Senate in 2008-2009. As a state lawmaker, he had forty pieces of legislation signed into law, including the landmark "Aryanna's Law" to protect children in daycare centers.

During his forty-five years of public service, Supervisor Benoit helped strengthen the local economy, protect neighborhoods from crime, improve transportation systems, and expand access to health care. His many accomplishments include establishing the CHP's permanent air operations unit in the Coachella Valley; closing Duroville, a dilapidated mobile home park where egregious living conditions existed for years, and releasing funds from the state to relocate 181 families from Duroville into safe housing; redirecting plans for the County Jail Expansion which is currently under construction in Indio; developing the University of California, Riverside, School of Medicine and Eagle Canyon Dam; and crafting a County Solar Policy that benefits communities near large solar plants. In recent years, he focused on the Salton Sea, health care, affordable housing, and transportation.

Supervisor Benoit was a loving and devoted husband, father, grandfather, brother, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.



On motion of Supervisor Ashley, seconded by Supervisor Tavaglione, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, January 17, 2017, be adjourned in memory of Howard "Ed" Reinecke, a prominent resident of Palm Springs, California for the past twenty years who dedicated his life to service in the private and public sectors.

Born in 1924 in Medford, Oregon, Ed grew up in Southern California and graduated from Beverly Hills High School in 1942. During World War II, he enlisted in the United States Navy and proudly served as a Radio Officer aboard a Gleaves Class Destroyer, the USS Cowie. After the war, he attended the California Institute of Technology, graduating with a degree in Mechanical Engineering in 1950.

Ed was a successful San Fernando Valley business man when he was elected to the United States Congress House of Representatives in 1964. He represented California's 27th District which extended from the western boundary of Los Angeles County and included a large part of the San Fernando Valley, extending north to include the Santa Clarita Valley, Antelope Valley, and parts of the Mojave Desert in Kern County. He was involved with key industries including the aerospace and was known as the "Slide Rule Congressman" because of his focus on mathematics and engineering.

In 1969, Ed was appointed by Governor Reagan to serve as Lieutenant Governor of California. He served on numerous Committees, Boards, and Commissions proposing innovative solutions to critical problems. An engineer by training, he worked to make education opportunities more efficient and accessible by making "excellent professors" available electronically to campuses across the state. His model anticipated, by 30 years, Massive Open Online Courses (MOOCs) and other on-line university course offerings are widely used today. Recognizing California's growing population and limited water resources, he established efficient water distribution systems in both California and Mexico.

Ed was a traditional conservative and strong advocate of small government, individual liberty, and the protection of the natural environment. He served on the Interior Affairs Committee and championed the protection of western rivers and fought to block the damming of the Colorado River. In 1983, he was elected unanimously as Chairman of California Republican Party and provided leadership to the State GOP.

Ed was a loving and devoted husband, father, grandfather, great-grandfather, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.
