BACKGROUND:

Summary

The new Magnolia Avenue Bridge over the railroad tracks, in Home Gardens between Lincoln Street and Buchanan Street, was completed in mid-2016. Before the bridge was constructed, the many businesses along this segment of Magnolia Avenue, obtained access from Magnolia Avenue. Now with the new bridge in place, access to the businesses is obtained through a frontage road that loops in front of the businesses and under the new bridge. This frontage road is required for local access to the businesses that front Magnolia Avenue who would otherwise have no access for their businesses. The name change from Magnolia Avenue to Magnolia Business Loop will provide clarity for customers looking for access to the businesses. In addition to the street name change, wayward signs have been installed to minimize confusion when searching for an address along this section of Magnolia Avenue.

County Counsel has approved Resolution No. 2017-029 as to form.

Impact on Residents and Businesses

The street name change will impact the business owners by having to update their addresses. All of the affected business were contacted and have agreed to the street name change.

Additional Fiscal Information:

The cost to install the street name signs and the administrative costs for renaming the street are included in the project budget. Proposition 1B, Trade Corridor Mitigation Fees (TCIF) will be used for this item.

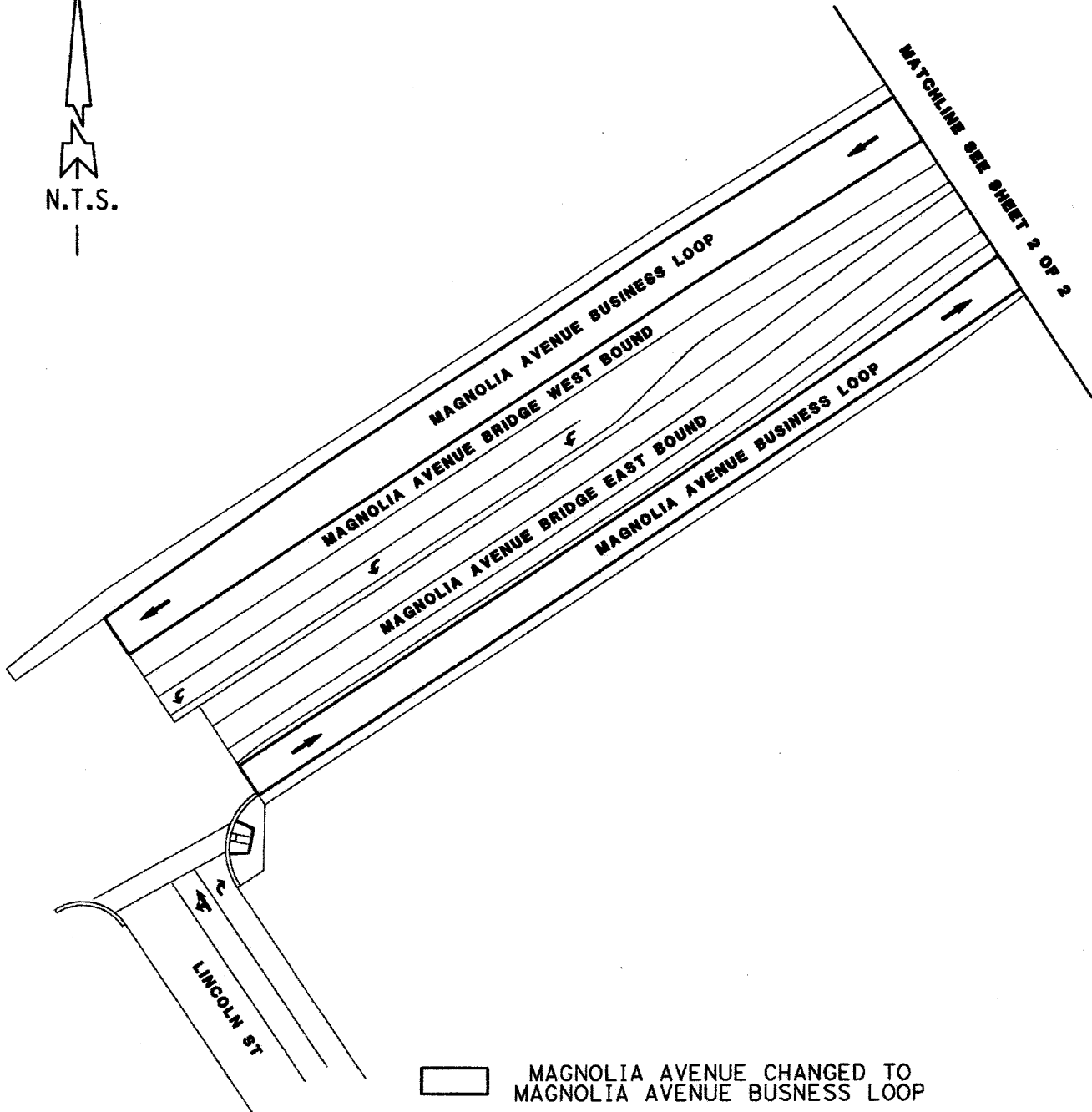

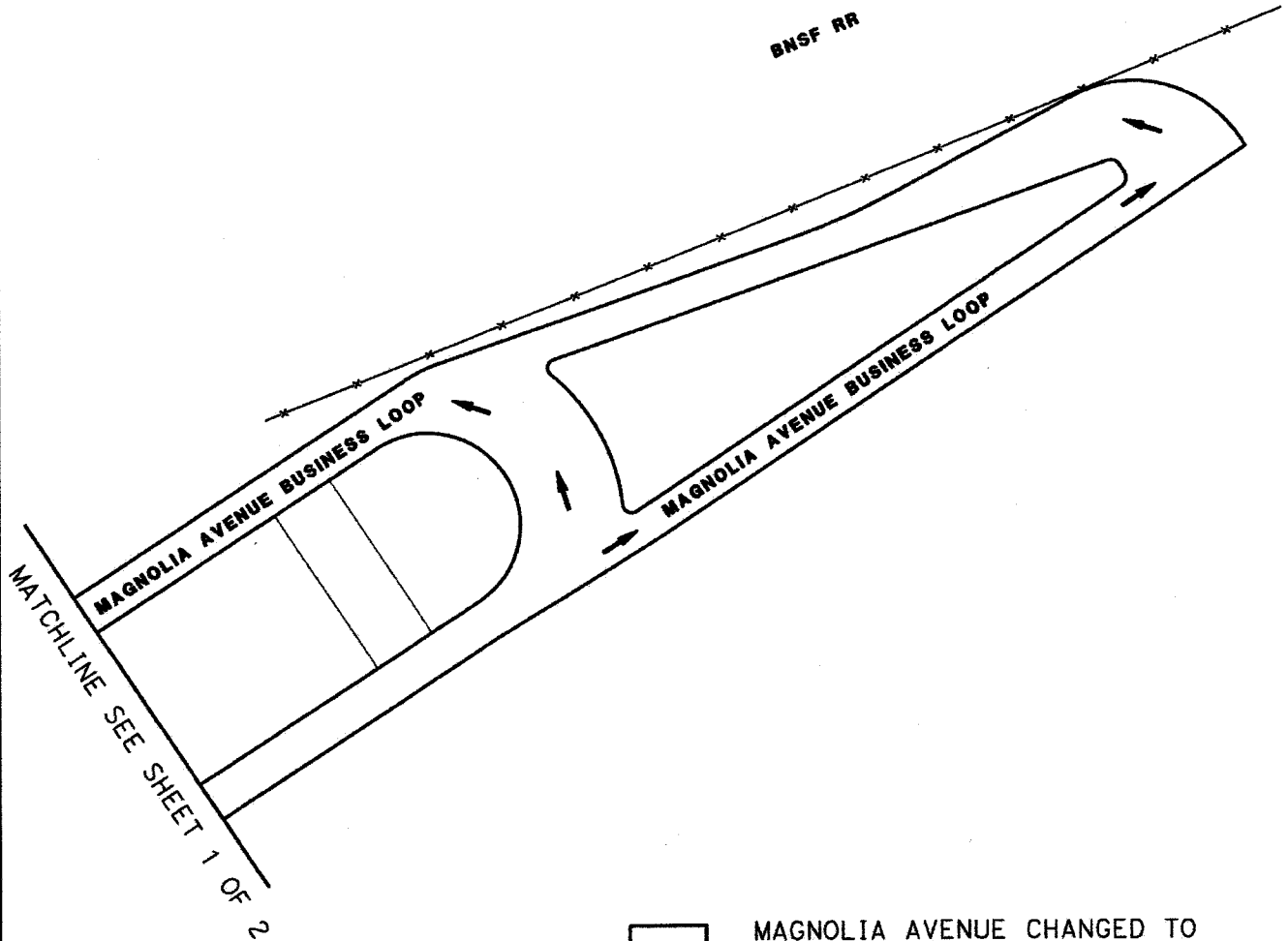


 MAGNOLIA AVENUE CHANGED TO MAGNOLIA AVENUE BUSINESS LOOP
