An inspirational force in fire service, Byron was chosen as Fire Chief of the Palm Springs Fire Department because of his national leadership and recognized management abilities. He had developed a reputation as an innovator in management concepts and as a strong administrative leader.

During his service at the Mountain View Fire Department, Byron directed the development of a Fire Protection Master Plan, which was published as a model in a report to the President and Congress in 1973. He worked towards establishing a "management by objectives" and a "system approach" to fire protection, which he also established with the Palm Springs Fire Department.

A supporter of the Palm Springs Fire Department, Byron faithfully made monetary donations whenever there was a function or charitable event. He recently sent a check in support of the California Fire Chiefs Association Administrative Fire Services Section fundraiser.

Born on August 16, 1946 in Pittsburgh, Pennsylvania, Dennis was raised in Redlands, California and graduated from Redlands High School in 1964. He attended Valley Junior College in San Bernardino and graduated from Cal Poly San Luis Obispo with a Bachelor of Science in Biology in 1968.

A decorated combat veteran, Dennis proudly served as a Naval Flight Officer (NFO) from 1969 to 1972. He served on the USS Constellation during her 1971/1972 combat cruise to Vietnam and flew more than 100 missions off the Connie. He also flew in the RA5C Vigilante for all but two of his combat missions. The other two missions were in the venerable F-4 Phantom. He was awarded seven Air Medals and the Presidential Unit Citation and was presented the Bronze Star.

Dedicating his career to public service, Dennis began working in the field of social welfare in 1973 for the State of California as a Program Analyst and rose to the rank of Deputy Director. He was responsible for a variety of "Welfare Reform Measures" which included the Statewide implementation and operation of the GAIN program, the development of a Statewide Automated Welfare System (SAWS), and the development of a Statewide Automated Child Support System (SACSS).

In 1992, Dennis joined the County of Riverside as Assistant Director for the Department of Public Social Services (DPSS) and was appointed Director of DPSS in 1995. He continued to emphasize the importance of putting people to work through Riverside's Welfare to Work Program which won the Innovations in American Government Award in 1996. Under his direction, the C.A.R.E. Team was established to assist the elderly with elder abuse prevention education and consumer fraud advocacy. This program was featured on NBC's Dateline and was a 2004 finalist for the Innovations in American Government Award. His commitment to children's services resulted in the County receiving additional funding, enabling the department to fill critically needed positions that help keep children safe.

In 2004, the Governor of California appointed Dennis as Director of the California Department of Social Services (CDSS). An inspirational force in leadership and dedication, he continued his vision of "Building Stronger Families, Building Stronger Communities, and Building a Stronger America."
