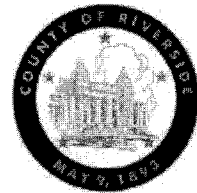





BACKGROUND: Community Designation funds will be given to the following organizations:

1. Riverside National Cemetery Support Committee-Concert for Heroes annual donation will be utilized to support the Concert for Heroes at Riverside National Cemetery to recognize and salute all veterans.

2. Fair Housing Council of Riverside County, Inc. - funding will be utilized to assist the housing programs, services and projects such as the 2017 Fair Housing Conference. The conference will bring together community non-profits, government officials, lenders, builders, policy makers and housing providers to address the issues of the future of housing in the Inland Empire.

3. Loving Me 1st – donation will support the all-girls student program (grades 9th to 12th) that helps to empower, guide, build self-esteem and leadership skills.

4. Muslim Family Foundation of the Inland Empire - donation will assist with programs and services to assist in educating the residents of Riverside County in social issues and community resources.

5. Assistant League of Temecula Valley - support will go to various affordability programs for students K-12 and have a need and are living below poverty level.

6. Xhanat - donation will support programs and services in assisting the education of the Arts for students within the Fifth District. Classes, workshops, shows and events will be their primary source for educating the targeted population.
