On motion of Supervisor Ashley, seconded by Supervisor Tavaglione, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, April 18, 2017, be adjourned in memory of Lyle Lavern Millage, a prominent resident of Cherry Valley, California whose true motto was "service above self."

Born on September 14, 1930 in Lincoln, Nebraska, Lyle grew up in Fontana, Bloomington, San Bernardino, Palm Springs, California and Eugene, Oregon. He graduated from San Bernardino High School in 1949 and proudly served in the United States Army Reserve from 1955 to 1963. After discharge, he followed heavy construction work with various contractors.

Lyle was married to Margaret Teachenor from 1959 until her passing in 2010. During their 52-year marriage, they had two sons and made their home in Cherry Valley. They were very active with the Beaumont Chamber of Commerce, Rotary Int., and Soroptimist Int. In 1970, Lyle's family and partner Pete Webster opened Alpen Equipment Rental and Millage and Sons in Beaumont. They operated the business for 18 years and the business remains open today as "All Purpose Rental."

An inspirational force in the community, Lyle was a member of the Beaumont-Cherry Valley Rotary Club since 1973. He founded the Riverside East Rotary Club in 1987 and became the Club's Grandfather. His most rewarding project was obtaining and relocating the building that now houses the Beaumont Chamber of Commerce. For his efforts, the Chamber of Commerce was later dedicated to Lyle. In 2002, he was named "Beaumont Citizen of the Year."

At the time of his passing, Lyle was "Director Emeritus" on the Chamber of Commerce Board of Directors and a Charter Member of the Beaumont Police Volunteer Patrol which he founded in 1993 and faithfully served until 2017. He served on the Career Tech Education Committee at Beaumont High School and was a Chairman on the San Gorgonio Memorial Hospital Foundation Board. He was honored by the Cherry Festival Association with the 2016 Heritage Award in recognition of his dedication, devotion, and commitment to the communities of Beaumont and Cherry Valley.

When Lyle married Nadine Lowder in 2014, he was welcomed into the family and loved as "PaPa Lyle." Their "perfect love" found late in life was a blessing and shining example to others. He was a loving and devoted husband, father, step-father, grandfather, great-grandfather, and friend.

Lyle's memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.
