

MINUTES OF THE BOARD OF SUPERVISORS
COUNTY OF RIVERSIDE, STATE OF CALIFORNIA



On motion of Supervisor Tavaglione, seconded by Supervisor Washington, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, May 2, 2017, be adjourned in memory of Raymond "Ray" Magnon, an 86-year-old longtime resident of Riverside, California who passed away on April 24, 2017.

Born in Niles, Ohio, Ray was 14 years old when his family moved to Riverside in 1944. He attended Poly High School, served in the Air Force as a plane mechanic during the Korean War, and later attended Chaffey College.

After working at Lockheed and at a local fiberglass company, Ray started his prominent career working as an electrician. Ultimately, he set off on his own and formed Service Electric which provided the electrical construction for many notable buildings in the City of Riverside including the Tyler Mall. In the 1970's, Ray's company was the largest electrical contractor in the State of California with hundreds of employees and offices in Riverside and Fremont. He also owned a plane and became a pilot to facilitate doing business on both ends of the state. When the stress took a toll on his health, he helped his best friend take over the company which still operates in Riverside today under a different name.

Ray next ventured into commercial real estate development. In 1977, he founded The Magnon Companies which developed and built many buildings in Riverside including the Sycamore Canyon Business Park and Hunter Park. He was also responsible for the construction of several apartment buildings in Canyon Crest including Bunker Hill. Many of the Magnon buildings have won awards for their design and beautification from the City and County of Riverside.

Throughout the years, Ray owned many other businesses including several Swiss Colony franchises, a steel fabrication company, and Canyon Steel. He also owned many restaurants starting with Ryan's Wharf, Magnone, Bossa Nova Grill, Jag's, and Ciao Bella. He loved being a business leader in the community and was well known to local political leaders as a voice for the business community.

Ray was a loving and devoted husband, father, step-father, grandfather, brother, uncle, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.

The Board of Supervisors commemorates his service to the County of Riverside.


