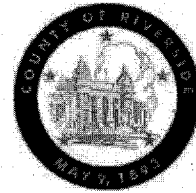



  - a. Graduating seniors, attending community colleges, public colleges or universities, private universities, or eligible trade schools (proof of acceptance required)
  - b. Proof of High School Graduation
  - c. Total number of hours that were contributed to the council
  - d. How many years served as a member on the YAC (up to \$250 per year served)
  - e. Has the YAC member demonstrated any growth
  - f. What sort of ideas or projects have been contributed to on the council
