On motion of Supervisor Tavaglione, seconded by Supervisor Washington, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, May 9, 2017, be adjourned in memory of Al Karnig, a 75-year-old resident of San Bernardino, California and former Cal State San Bernardino President who passed away on May 4, 2017.

Born in March 1942, Al became the third President of Cal State San Bernardino in 1997 and retired in 2012. During his time as president, the university raised \$40 million for a four-building, non-state funded campus in Palm Desert; ranked in the 96th percentile in the degree of learning students acquired while in college; and had the second-highest enrollment of both African American and Latino students of any California public university, with 70 percent of graduates being the first in their family to complete college.

An instrumental force in education and the community, Al will always be remembered as a "visionary leader with an educator's heart." He started and led the Infant-Toddler Success organization and believed that the first 36 months of life are when 80 to 85 percent of brain development occurs. He was also a board member on the Making Hope Happen Foundation and served on the KVCR Educational Foundation Board.

Al was a loving and devoted family man, mentor, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.

Born on January 17, 1939 in Blythe, California, Ken attended Blythe Primary School, Blythe Grammar School, Blythe Junior High School, and Palo Verde High School, graduating in 1956. After graduating from the University of California, Riverside in 1961, he began a prominent career in the field of education with his first teaching job at Santa Maria High School. In 1963, he started teaching at Blythe Junior High School where he remained until 1975. In 1975, he began the next step in education, working as a counselor at Palo Verde High School (PVHS).

An instrumental force in education and the community, Ken sponsored the Junior Statesman Club from 1980 to 1985 and started the Model UN program that ran until 1987. In 1985, he joined a group of trainees to begin a drug intervention program at the high school and completed a certificate program in alcohol and drug studies in 1989. From 1989 to 1993, he served in the capacity as a crisis counselor for both adults and students. He also conducted insight groups for the Drug Intervention Program and facilitated Alateen, A.A., and N.A. groups on campus.

Ken retired from education in 1999, but continued to work for a semester in 2000 and 2002 at PVHS. He also worked as a part-time counselor at Palo Verde College from 1984 to 2001. His most significant honor was having the 1979 yearbook "The Echo" dedicated to him.

After settling in Cathedral City in 2003, he volunteered for four years with the Desert Aids Project. For several years, he worked at the Arizona Inspection Station and at the agriculture sheds during the summer months. In 2007, he began a part-time job at the AIM Mail Center in Rancho Mirage.

A "faithful" Catholic since 1960, Ken taught high school CCD classes from 1965 to 1975. He became a Lector and Eucharistic Minister at St. Joan of Arc in 1987 and was also a member of the RCIA team from 1990 to 2002.

Ken was a loving and devoted family man, mentor, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.

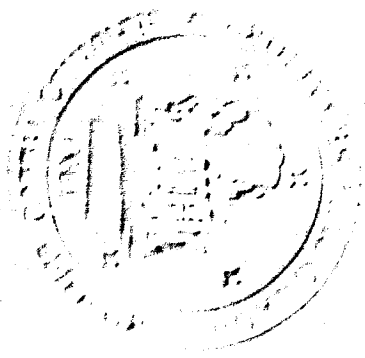
