



BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the May 2, 2017 City of Lake Elsinore Special Measure Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On March 21, 2017, the Board of Supervisors approved the conduct of election services for the City of Lake Elsinore. Election costs fully reimbursable from the City of Lake Elsinore are approximately \$75,000.

The election was held on May 2, 2017 with about 16% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast at the City of Lake Elsinore Special Measure Election.

Impact on Residents and Businesses

Registered voters in the City of Lake Elsinore had the opportunity to vote on an Initiative Measure Revising the Alberhill Villages Specific Plan Governing the Future Development of Approximately 1,400 Acres Located in Northwest Lake Elsinore, South of Interstate 15 and West of Lake Street.

As approved by the Board of Supervisors on March 21, 2017, the City of Lake Elsinore will reimburse the Registrar of Voters for the full cost of conducting their election.

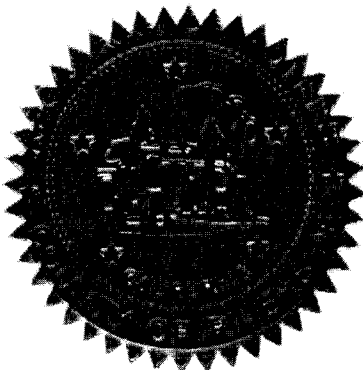
