**BACKGROUND:**

Patrick Ellis, President/CEO of Murrieta Chamber of Commerce, has expressed interest in becoming a Workforce Development Board (WDB) member for District Three. Mr. Ellis has 10 years of experience in this capacity and previously with the Moorpark Chamber of Commerce in Ventura County. He has also served as president of the Chambers of Commerce Alliance of Ventura and Santa Barbara Counties, as well as the Federated Chambers of Commerce of Ventura County. He completed the Western Association of Chamber Executives Academy, a three-year training program promoting a new era of chamber management.

During Mr. Ellis' time as President/CEO, the Murrieta Chamber of Commerce has been awarded a contract through the State of California's Employment Training Program (ETP) the initial contract in 2015 and helped to train an average of 261 local employees. The contract was then amended and the amount increase and the number of local trainees doubled. This second contract was awarded March of 2017 estimating over 460 local employees to be trained and serve local business needs.
