#### **BACKGROUND:**

#### **Summary**

The Riverside County Department of Public Social Services-Children's Services Division (DPSS-CSD), in cooperation with the HOPE Collaborative and Riverside County's Child Abuse Prevention Council (CAPC), completed a countywide Community Needs Assessment (CNA) in the fall of 2016. The purpose of the CNA was fulfilling three DPSS-CSD needs:

- 1. Identifying community service needs and barriers to service, in relation to child abuse and neglect prevention, intervention and treatment.
- 2. Meeting funding requirements and guidelines set by the State of California Office of Child Abuse Prevention (OCAP), providing oversight and consultation in relation to funded programs: Child Abuse Prevention, Intervention and Treatment (CAPIT); Promoting Safe and Stable Families (PSSF); Community-Based Child Abuse Prevention (CBCAP) and Children's Trust Fund (CTF).
- 3. Using findings from the CNA to guide funding priorities for the use of CAPIT, PSSF, CBCAP and CTF funds.

The CNA process began in June 2016 with a goal of identifying community service needs and barriers in relation to child abuse and neglect prevention, intervention and treatment. As part of the process, DPSS-CSD and the Hope Collaborative surveyed a diverse population of Riverside County residents and service providers. Efforts were made to survey participants that could be representative of the county, while capturing information to appropriately guide funding priorities. The needs assessment and recommendations for use of CAPIT/PSSF/CBCAP/ CTF funds were reviewed and approved by the CAPC (HOPE) Board of Directors on April 26, 2017.

Results of the needs assessment identified the following five service priorities most important to the prevention of child abuse by service providers:

- 1. Individual, conjoint, family or group counseling services designed to prevent the occurrence/recurrence of child maltreatment or domestic violence;
- 2. Anger Management classes designed to stop abusive and violent incidents by teaching alternative methods of expressing emotions, how to negotiate differences and by holding offenders accountable for their behavior:

- 3. Mental health counseling for children and parents/caregivers;
- 4. Substance abuse counseling and services for children and parents/caregivers;
- 5. Parent Education classes for adults who need assistance strengthening their emotional attachment to their children, learning how to nurture their children and understanding general principles of discipline, care and supervision;
- 6. Post Adoption services designed to address adjustment issues and maintain the stability of the adoptive relationship.

DPSS intends to use CAPIT/PSSF/CBCAP/ CTF funds through the release of multiple Requests for Proposals (RFP) and/or Requests for Qualifications (RFQ) to secure contractors to provide these services, effective July 1, 2018, for residents of Riverside County and/or to augment existing or fund new services consistent with the needs assessment criteria.

DPSS also intends to issue an RFP for the provision of CAPC services, effective July 1, 2018.

#### **Impact on Residents and Businesses**

The CNA will ensure adequate service offerings are made available to families or individuals in need of the identified services (Anger Management, Counseling, Parenting Education, Domestic Violence and Substance Abuse) designed to prevent the occurrence/recurrence of Child Maltreatment.

#### INTRODUCTION

#### Background

The Riverside County Department of Public Social Services-Children's Services Division (DPSS-CSD) in collaboration with the HOPE Collaborative, Riverside County's Child Abuse Prevention Council (CAPC), completed a county-wide Community Needs Assessment (CNA) in the fall of 2016. The CNA was completed with the purpose of fulfilling three DPSS-CSD needs.

- 1) To identify community service needs and barriers to services in relation to child abuse and neglect prevention, intervention, and treatment.
- 2) To meet funding requirements and guidelines set by the State of California Office of Child Abuse Prevention (OCAP), which provides oversight and consultation in relation to the following funded programs: Child Abuse Prevention, Intervention and Treatment (CAPIT); Promoting Safe and Stable Families (PSSF); Community-Based Child Abuse Prevention (CBCAP); and County Children's Trust Fund (CCTF).
- 3) To use findings from the CNA to guide funding priorities for the use of CAPIT, PSSF, CBCAP, and CCTF funds.

#### Allocation of Funds

Riverside County DPSS-CSD is responsible for the contracting, development of measurable outcomes, and monitoring of CAPIT, PSSF, CBCAP, and CCTF funds to eligible agencies within the county. In Riverside County, these funds are allocated through a competitive Request for Proposal process that is instituted and driven by findings from the CNA. Agencies participating in the competitive process must also meet specific program funding requirements and guidelines in order to be eligible.

#### **METHODS**

#### Overview

The CNA process began in June 2016 with the goal of identifying community service needs and barriers in relation to child abuse and neglect prevention, intervention, and treatment. As part of the process CNA, DPSS-CSD and HOPE Collaborative surveyed a diverse population of Riverside County residents (1,483 participants) and service providers (307 participants) for a total of 1,790 participants. Efforts were made to survey participants that could be representative of the county, while capturing information to appropriately guide funding priorities.

#### Sampling, Data Collection, and Data Analysis

Two CNA surveys were developed for the purpose of data collection through paper and online formats. CNA data collection concluded in December of 2016. Paper survey participants (1,483) completed the survey with the assistance of DPSS-CSD or HOPE Collaborative staff at one of 40 pre-determined data collection activities. These activities included focus groups, resource fairs, events at service provider centers, and other community activities held across the county. The online survey was distributed to participants (307) using a web-based data collection system called Google Forms. Information collected through the paper survey was manually entered by DPSS-CSD staff into the Google Forms system. The CNA data was analyzed using the Google Forms analytics to calculate simple response percentages.

#### **RESULTS**

#### Community Survey (1,483)

Table 1. Community Identified Needs to be Addressed

The majority of respondents identified substance abuse of parent/caregiver (43%) as the number one need to be addressed in their community. This identified need was followed by three other needs that the community identified as important to address which include: substance abuse of child/youth (37%); domestic violence (33%); and child/youth mental illness (25%).

The majority of respondents identified lack of awareness (58%) as the number one barrier to services in their community. This identified barrier was followed by three other barriers that the community identified as important to address which included: embarrassment (40%); language (34%); and lack of family support (30%).

Data shows that there were no significant differences between the community needs and barriers identified at the county level versus supervisorial districts.

#### Service Provider Survey (307)

The majority of respondents identified substance abuse of parent/caregiver (80%) as the number one need to be addressed in their community. This identified need was followed by three other needs that the service providers identified as important to address which included: parent/caregiver mental illness (78%); domestic violence (69%); and child/youth substance abuse (65%).



The majority of respondents identified lack of awareness (78%) as the number one barrier to services in their community. This identified barrier was followed by three other barriers that the service providers identified as important to address which include: embarrassment (67%); location of services (67%); and lack of family support (56%).

Data shows that there were no significant differences between the community needs and barriers identified at the county level versus supervisorial districts.

#### OVERVIEW OF FUNDING SOURCES

#### **CAPIT**

Funding Allocation for FY 2016/2017: \$619,556.00

CAPIT funds are available to public/private non-profit agencies with programs that serve the needs of children at risk of abuse or neglect. Funding priority is given to agencies that have demonstrated effectiveness in prevention or intervention of child abuse or neglect. Ninety (90) percent of funds must be allocated to program services (See Appendix 2 "List of Allowable Services and Activities by Funding Program" for examples of CAPIT allowable services). Ten (10) percent of funds can be used for administrative costs. Specific examples of allowable services that can be used to address mentioned needs and barriers follow.

- Behavior health, mental health services
- Domestic violence services
- Family Resource Center or other multi-service center
- Peer support
- Substance abuse services

#### **PSSF**

Funding Allocation for FY 2016/2017: \$1,044,386.00

PSSF funds are available to public/private non-profit agencies with programs that provide coordinated services for children and families across the continuum of prevention through aftercare. Funded agencies must focus efforts to address one or all four of the PSSF program components: 1) Family preservation; 2) Community based family support; 3) Time limited family reunification; 4) Adoption promotion and support. Ninety (90) percent of funds must be allocated to program services (See Appendix 2 "List of Allowable Services and Activities by Funding Program" for examples of PSSF allowable services). Ten (10) percent of funds can be used for administrative costs. Specific examples of allowable services that can be used to address mentioned needs and barriers follow.

#### **CBCAP**

Funding Allocation for FY 2016/2017: \$78,828.00

CBCAP funds are available to public/private non-profit agencies with programs that provide community based services to prevent and/or reduce the risk of child abuse and neglect in the community. Funded agencies must aim to strengthen and support families in the community through community based collaborations and public/private partnerships. Ninety (90) percent of funds must be allocated to program services (See Appendix 2 "List of Allowable Services and Activities by Funding Program" for examples of CBCAP allowable services). Ten (10) percent of funds can be used for administrative costs. Specific examples of allowable services that can be used to address mentioned needs and barriers follow.

- Network development

#### **CCTF**

Funding Allocation for FY 2016/2017: \$1,923,122.00

CCTF funds are available to private non-profit organizations or public institutions of higher education, with programs that provide community services to prevent or treat child abuse and neglect. Funded agencies must aim to support child abuse prevention councils (CAPCs). Ninety five (95) percent of funds must be allocated to program services (See Appendix 2 "List of Allowable Services and Activities by Funding Program" for examples of CCTF allowable services). Five (5) percent of funds can be used for administrative costs. Specific examples of allowable services that can be used to address mentioned needs and barriers follow.

- Information & referral services
- Network development

#### **RECOMMENDATIONS**

Findings from the CNA have provided insight to what Riverside County community and service providers have identified as community service needs. Findings also reveal several barriers to services in relation to child abuse and neglect prevention, intervention, and treatment. As a result, Riverside County DPSS-CSD has been able to identify overlapping needs and barriers which can be used to guide funding priorities for the use of CAPIT, PSSF, CBCAP, and CCTF funds. The identified overlapping needs and barriers are as follows:

#### Identified Overlapping Needs to be Addressed:

- o Substance abuse of parent/caregiver
- Substance abuse of child/youth
- o Domestic violence
- o Parent/caregiver or child/youth mental illness

#### Identified Overlapping Barriers to be Addressed:

- Lack of awareness
- o Embarrassment
- Lack of support
- Location of services

It is recommended that DPSS-CSD allocate CAPIT, CBCAP, PSSF, and CCTF funds to support services that address these identified overlapping needs and barriers. Services funded through these funding sources should implement evidence-based or evidence informed practices that are culturally sensitive and in the appropriate language necessary for DPSS-CSD clients.

- 1) Utilization of the funds to support existing services consistent with the community needs assessment criteria
- 2) Implementation of new CSD services consistent with the needs assessment criteria
- 3) Increases to the funding amounts recommended for the RFP based on changes in the environment particularly reductions in the availability of Medi-Cal funding for services addressed through the RFPs

The Needs Assessment identified the lack of awareness and location of services as significant barriers to utilization. In order to increase the utilization of needed services, it is recommended that the RFP/Qs require respondents to address how they will make potential clients aware of the availability of services, and how they will ensure accessibility of the services.

<sup>\*\*</sup>A balance of \$607,034 remains. Based on historic expenditures of funds allocated for services identified as most needed by the community needs assessment, at this time it is recommended that the \$607,034 not be utilized through the RFP process. Instead, three potential uses for these funds will be explored:
