

BACKGROUND: Community Improvement Designation Funds will be allocated to nine (9) 2017 High School Graduates who have served on the Second District Youth Advisory Council.

1. The Scholarship award is designed to reward Second District Youth Advisory Council Members (YAC) hard work, to assist with furthering their education and ultimately improve our community.
2. Eligibility considerations are as follows:
 - a. Graduating seniors who attend community colleges, public colleges or universities, private universities or eligible trade schools;
 - b. Proof of high school graduation;
