RECOMMENDED MOTION: That the Board of Supervisors:

- 1. Approve the Managed Care Provider Aggregate in the amount of \$7,250,000 annually through FY21/22;
- 2. Exempt the Purchasing Agent from the sole source requirement when adding new providers, not to exceed \$100,000 without securing competitive bids while staying within the approved aggregate amount;
- 3. Authorize the Purchasing Agent, in accordance with Ordinance 459, based upon the availability of funding and as approved by County Counsel to: a) execute FY17/18 Managed Care Provider agreements identified in Attachment A; b) shift funds among the providers while staying within 10% contingency of the approved aggregate amount of \$7,250,000; c) sign annual renewals; and d) sign amendments that do not change the substantive terms of the Agreements through June 30, 2022.

BACKGROUND:

Summary

The Managed Care Mental Health Plan requires Riverside University Health System-Behavioral Health (RUHS-BH) to operate a continuum of care system that consists of County-operated and contracted service providers who deliver a variety of mental health treatment services to Medi-Cal beneficiaries within each geographic region of Riverside County. On July 1, 2014, (3-29) the Board of Supervisors approved Managed Care Provider Aggregate in the amount of \$7,250,000 annually through June 30, 2017.

Due to the specialized services provided by the vendors listed in Attachment A, RUHS-BH requires the flexibility to add vendors as needed to ensure continuity of care. Such vendors are subject to providing proof of Medi-Cal or other certification, appropriate licensing and/or other standard review qualifications.

Impact on Citizens and Businesses

These services are a component of the Department's system of care aimed at improving the health and safety of consumers and the community.

Additional Fiscal Information

The Managed Care Agreements listed in Attachment A are funded by Medi-Cal and other applicable State funds, and have termination clauses in the event that applicable Federal, State and/or County funds become unavailable for service provision. Each provider Agreement amount is based on a projected utilization multiplied by the County rate listed below. No additional County funds are required.

Contract History and Price Reasonableness

The current Managed Care rates for individual and agency providers are negotiated based on industry standards. These current services rates are as follows:

Therapy (PhD, LMFT and LCSW) \$1.27 per minute Medication Services (Psychiatrist) \$2.75 per minute
