In 2012, Charles was awarded the Congressional Gold Medal for his service during World War II, serving in Military Intelligence Service (MIS) under General MacArthur. He was stationed in Japan where he played a significant role in the war effort and met his future bride.

A hardworker and leader in the community, Charles served as President of the local Lion's Club and was well loved and respected. In later years, he shared about his life experiences with elementary and high school students, focusing on his Japanese internment, service in the Military, and war bride.

Charles was a loving husband to his wife Jeanne who preceded him in death in 2013 and a devoted father, grandfather, great-grandfather, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.

On motion of Supervisor Perez, seconded by Supervisor Washington, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, June 6, 2017, be adjourned in memory of Paul Tranel Selzer, a prominent resident of Palm Springs, California who passed away on April 30, 2017.

Born on August 7, 1940 in St. Louis, Missouri, Paul graduated from Stanford Law School in 1965 and began his legal practice in Riverside, California. Initially, the primary focus of his work was estate planning and real estate development. After moving to Palm Springs to expand his firm, he continued working as an attorney but shifted his focus to natural conservation. He became an expert in this field, primarily in connection with the protection and conservation of endangered species. He negotiated conservation agreements and habitat conservation plans among local governments, developers, and environmental groups in California, Arizona, Texas, Florida, and Nevada.

Paul's expertise became nationally recognized and his work resulted in the permanent conservation and management of over 500,000 acres for the benefit of both the indigenous plant and animal species as well as human populations who now enjoy the preserved open spaces. He helped form and served on the Board of Directors of The Friends of the Desert Mountains for over 30 years. He played a major role in the permanent conservation and protection of over 50,000 acres in the Coachella Valley and the surrounding mountains. For his outstanding efforts and service, the Secretry of the Interior of the United States honored him with the prestigious Silver Eagle Award.

Paul was a loving husband to his wife who preceded him in death and a devoted father, grandfather, attorney, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed but never forgotten.

Born on December 13, 1937 in Milwaukee, Bruce earned his Master's Degree in Public Administration from Arizona State University in the early 1960's and became an asset to city government for 25 years. He was the first City Manager of Simi Valley, California and retired as City Manager of Palm Desert, California.

Bruce began his career as an Assistant City Manager in Claremont, then became City Manager of Newark in Northern California, and later was City Manager of Brisbane. He was Simi Valley's first City Manager from 1969 to 1974. After leaving Simi Valley, he became the Public Administrator/Public Guardian of Los Angeles County for four years. In that role, he oversaw the estate of billionaire businessman Howard Hughes. He then went into the private sector, working for accounting firm Coopers & Lybrand. One of his clients was the City of Palm Desert, and through that connection, he became Palm Desert City Manager. He held the position from 1983 to 1995, when he retired due to Multiple Sclerosis.
