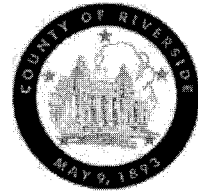





**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

**1. Los Medicos Voladores (Flying Doctors) - \$1,723**

For the past twenty years, Los Medicos Voladores has held the Oasis Flying Doctors and Coachella Valley Medical Volunteers event in Thermal. Los Médicos Voladores is a 100% volunteer-based, non-religious, nonprofit organization that aims to improve the health and well-being of uninsured and underinsured people, through education and the provision of no-cost, high-quality medical, dental, and optometric clinics. Every year doctors fly in to the Coachella Valley to join other local volunteers to provide healthcare services to an underserved population. The CID funds will help cover the overall expenses of this event.

**2. All Desert Aquatics, Inc. - \$2,000**

All Desert Aquatics is a 5013c which provides a variety of aquatic programs in the city of Desert Hot Springs. The program offers low cost or free swim and water safety courses to low income individuals. CID funding will be used to subsidize the costs of the program.

**3. Regional Access Project - \$3,000**

The Regional Access Project Foundation serves as the fiscal agent for the Fourth District Youth Advisory Council scholarship fund. The Youth Advisory Council (YAC) serves as a voice for issues and concerns of high school students in the Fourth District. YAC members volunteer in community service projects and participate in monthly meetings. The CID funding will be used for the 2018 senior class of YAC members who apply and meet the scholarship criteria.
