Born on October 6, 1944 in Kansas City, Missouri, Carolyn had always excelled in "writing." After taking a Journalism class in junior high school, she was named Editor of her junior high school newspaper as well as her high school and Long Beach college newspapers. She continued to write professionally at Smith International and Carl Karcher Enterprises. Despite her post-high school education being cut short, she obtained her BA in American Studies at Californa State University at Fullerton.

When Carolyn and her husband Vick Knight moved to Canyon Lake in 1981, she retired after years of being a corporate editor in Orange County and ultimately emarked on a new career. After being asked to edit The Canyon Lake Home Owners Club's newsletter, she became the first Editor and part owner of "The Friday Flyer," a newspaper converted in 1990 from a single sheet handed out at the gates every Friday. She wrote almost the enitre content of the newspaper for the next 25 years before retiring in 2007.

A true humanitarian and inspirational force in the community, Carolyn will always be remembered for her dedication, generosity, and positive attitude. Her first major crusade was covered by CBS's 60 Minutes with Harry Reasoner and included testifying before Congress. She had almost died nine different times after ingesting sulfites to which she was allergic. Her efforts resulted in regulations at restaurants and in getting wine labeled. She received many honors including a bronze plaque at the Staples Center and being named Riverside County's "Distinguished Woman of the Year" by YWCA and other civic groups.

When she was later diagnosed with breast cancer, Carolyn met the challenge with "bravery and dignity." She advocated for other women and was one of the founders of the support group "Bosom Buddies." She also became active in the Susan G. Komen Foundation and other cancer awareness programs. She was honored as Riverside County's "Local Hero" in a fund-raising event hosted by BMW of Riverside's "Drive for the Cure" promotion.

Carolyn was a loving wife to her husband Vick who preceded her in death and a devoted mother, step-mother, grandmother, and friend. Her memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be dearly missed but never forgotten.
