BACKGROUND:

Summary

On October 6, 2015, Item 3-24, the Board of Supervisors (Board) approved in-principle the Nuview Library project and estimated project budget in the amount of \$2,000,000. On April 11, 2017, Item 3-17, the Board approved the plans and specifications for the project and authorized the Clerk of the Board to advertise for bids using the General County Facilities Level 1 prequalified list of contractors.

On April 25, 2017, a mandatory job walk was held and a total of nine contractors attended the job walk, three of which were pre-qualified. On May 19, 2017, a bid opening was conducted and the Economic Development Agency (EDA) received two bids for the Nuview Library project; one bid from Hal Hays Construction Inc. and the second from Angeles Contractor, Inc. Both bids exceeded the approved construction budget; therefore, after further review, EDA recommends the Board formally reject all bids for the Nuview Library project and allow EDA to seek an alternative means of delivering the project.

Impact on Residents and Businesses

While it may cause a brief inconvenience in constructing the Nuview Library project, the existing library will continue to function in place without impacting the public and staff. Rejecting all bids and allowing EDA to determine an alternate means of project delivery will provide more savings opportunities and improved value to the community.
