Born on November 27, 1928 in Los Angeles, California, "Burt" was adventurous and independent from an early age. He ran away from home at the age of 11 to go live on his grandparent's farm in Lexington, Kentucky. He returned to Los Angeles when he was 15 and went on to become the Staff Photographer for the Hollywood Canteen (USO).

After high school, Burt continued as a Professional Photographer but eventually found his way into a machine shop as a Janitor and in six months became the Manager of Hollywood Tool and Die. He bought his own shop a few years later named Micro Tool and Engineering. The shop quickly expanded and gained such a reputation that he was making precision engineered parts for space launches at Cape Kennedy. He won commendations from the Department of the Navy and the U.S. Government for providing parts for the moon landings, as well as engineered prototype parts for Aerospace and Military. Ultimately, Burt sold his precision machine shop in Los Angeles and moved to Rancho Mirage in 1982. He purchased Palm Desert Self Storage which he owned for over 30 years.

An inspirational force in the community, Burt served as the President of Temple Sinai for over 9 years. During that time, he expanded the temple's membership and financial support. He received many awards from various organizations including The Arthritis Foundation, The State of Israel Bonds, The ADL (Man of the Decade), the Jayne Wyman Award for the Arthritis Foundation, the Torch of Learning Award from the American Friend of the Hebrew University, Man of the Decade from the Brotherhood of Temple Sinai, and a Letter of Commendation from Bill Clinton. He was also an Executive Board Member of the Hebrew University. He received the Senior Inspiration Award from the City of Rancho Mirage and multiple commendations from members of the U.S. Senate, House, and Congress.

On motion of Supervisor Perez, seconded by Supervisor Tavaglione, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, July 11, 2017, be adjourned in memory of Marion Goldin, a 76-year-old prominent resident of Washington DC and Palm Springs, California who passed away on June 15, 2017.

A “seminal figure” in the history of television news, Marion was an “immensely brilliant, talented, and skilled reporter and producer” who did pioneering work and broke through the proverbial glass ceiling at a time when few women achieved that rank. With a Bachelor’s Degree from Barnard College and a Master’s from Harvard, in the mid-1960’s she joined CBS News initially in a clerical role. She then went to work for CBS Commentator Eric Sevareid who relied on her intelligence, providing a formative phase in her professional development.

After being promoted to producer and proving herself at a series of political conventions, Marion became one of the “premiere producers” at 60 Minutes. Over the course of 15 years, from 1972 to 1988, she served as Senior Producer for ABC News 20/20, working closely with Correspondent Mike Wallace. During her prominent career as one of the first and best female producers, she won four Emmys for her work. She subsequently served as Senior Producer for the NBC Newsmagazine Expose and produced and reported the PBS Frontline documentary, Other People’s Money, an investigation into Charles Keating, and the savings and loan scandal.

Beginning in the early 1990s, Marion made Palm Springs her second home. She led an equally active cultural and social life and became a major sponsor and participant in numerous events and charities. She was a member of the Historic Tennis Club and was known for giving wonderful parties honoring special guests. She was an “Angel” sponsor of the Rancho Mirage Writers Festival and an avid annual attendee from its inception in 2014. She was in the President’s Circle at the Palm Springs Art Museum. She was also a sponsor and ardent fan of the Palm Springs International Film Festival. She also actively participated in Modernism Week events, including touring mid-century homes to inspire the design of her own home.

Marion’s memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be greatly missed but never forgotten.


