BACKGROUND:

The Application for County-Wide Arts Services, which is to be submitted to the California Arts Council, requires a local government resolution designating the Riverside Arts Council as the organization to execute the 2017-2018 State-Local Partnership Program Grant Contract with the California Arts Council.

This was an ongoing requirement which the Board of Supervisors has supported with its approval annually for 20 years, until the California Arts Council suspended State-Local Partnership funding in 2002.

RESOLUTION 2017-147

APPROVING APPLICATION FOR COUNTY-WIDE ARTS SERVICES AND DESIGNATING RIVERSIDE ARTS COUNCIL TO EXECUTE GRANT CONTRACT WITH CALIFORNIA ARTS COUNCIL

WHEREAS, the California Arts Council and the California State Legislature have established a State-Local Partnership Program designed to encourage local cultural planning and decision making and to reach; and

WHEREAS, an Application for County-Wide services by the Riverside Arts Council for the County of Riverside has been submitted to this Board of Supervisors; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on July 25, 2017, that the Application for County-Wide Arts Services prepared by the Riverside Arts Council is hereby approved.

BE IT FURTHER RESOLVED that the Riverside Arts Council is hereby designated to execute the 2017-2018 Application and Grant Contract for County-Wide Arts Services contingent upon approval of the Application and contract by the Council.
