I was referred to you in regards to equipment your agency is replacing.

I am the Chief of Ehrenberg Fire District in Ehrenberg Arizona. Our district encompasses an area from the Colorado River Indian Reservation to the North and East Boundaries. Colorado River for the West Boundary and 7 miles South of 1-10 for the South Boundary. We also cover 10 miles of Interstate 10.

Our response area is predominately rural with harsh desert terrain and the recreation activity areas on the river.

We mutual aid with Riverside County CAL-FIRE, Colorado River Indian Reservation (CRIT) and Quartzsite Fire District. We are proud to say we have responded for mutual aid with your agency. It has also been great honor to have participated in multiple training sessions with your agency that has greatly helped our effectiveness to assist your agency.

Our population is approximately 1900 permanent residences. We do however have a rather large increase in population during the summer weekends and the winter months with visitors residing within our district.
