BACKGROUND:

Summary

Each year, Exclusive Care contracts with an actuary to calculate the amount that should be reserved for claims that have been incurred but not reported (IBNR). The IBNR is reported as a part of the unpaid claims liability, which also includes reported but unprocessed claims and processed but unpaid claims. This year, the recommended reserve as of April 30, 2017 is \$14.6 million. The recommended current year adjustment to the reserve is \$3.3 million. Exclusive Care does not have sufficient appropriations to book this recommended adjustment.

On June 29, Exclusive Care received proceeds from a stop loss reimbursement of \$2.5 million. This revenue was not included in the 16/17 revenue budget. The budget adjustment attached will recognize the revenue and increase the claims appropriation allowing Exclusive Care to make the recommended adjustment to the reserve balance. The requested budget adjustment is provided in Schedule A.

Impact on Residents and Businesses

There is no impact on residents or businesses in the County of Riverside.

Additional Fiscal Information

No county general funds will be required. This budget adjustment will be wholly (100%) funded by Exclusive Care stop loss reimbursement.
