

Larry graduated from high school at 16 years of age and went to work for Sears as a stock boy. A wizard with numbers, he was hired by Capwells Department Store as the Cash Manager and was soon promoted to Credit Manager. After the crash of 1929 and the resulting Depression, he supported his parents and seven siblings until the country recovered.

Larry continued his career in accounting and finance until 1950 when he started a new career in construction. He built his first apartment building in 1964 in Huntington Beach, California. His partner in the project was Fredricks Development Company. They were so pleased with the results that they hired him to be the Vice-President of Apartment Construction for Fredricks, which he did until 1980 when he retired.

In 1972, Larry and his wife Kay moved from Corona Del Mar to Indian Wells in the Sandpiper community where they lived out their lives. He was the first president of his Sandpiper HOA Association and contributed to the building of St. Francis of Assisi Catholic Church in La Quinta. He enjoyed dancing, golf, bridge, and gin rummy.

Born on October 5, 1934, Jim's grandparents arrived in the Coachella Valley in 1915 to homestead and raise their sons. They purchased the Palm Springs Water Company which remained a family enterprise until it was bought by the Desert Water Agency in 1966. Jim graduated from Palm Springs High School in 1952 and Stanford University in 1956. After college, he served in the U.S. Navy in Pensacola, Florida, as an officer, aviator, and instructor. He returned to Palm Springs in 1960 with his bride, Carole McArdle Stanford. Jim was active in the insurance and real estate brokerage business, first as broker owner of Hicks Insurance, and then as the majority stockholder and president of Eadie Adams Realty Company. Later in his career, he provided consulting services to businesses and investors.

A lifelong champion of many civic and charitable organizations, Jim served in leadership roles for the Palm Springs Jaycees, the Palm Springs Chamber of Commerce, the Palm Springs Planning Commission, the Desert Water Agency, the O'Donnell Golf Club, the Palm Springs Desert Museum, the Desert Healthcare Foundation, and the Friends of the Palm Springs Library. He was also dedicated to serving the needs of the homeless and helped form what became known as the Palm Springs Homeless Task Force to advocate for a full service facility in the west end of the Coachella Valley. Through his tireless efforts and the support of many people, especially former Supervisor, Roy Wilson, he saw the 2009 construction of a shelter that could accommodate as many as 120 homeless persons.

As a member of the Palm Springs Club since the early 1960s, Jim spent lunchtimes perfecting his dominoes skills and regularly taking the top prize in tournaments. He was an armchair botanist and enjoyed reading. He was also a trailblazer, leading his family and friends on hikes from their cabin in Snow Creek to the falls that cascade down Mount San Jacinto.
